#### Title

1. These Regulations may be cited as the Melbourne Cricket Ground (Amendment) Regulations 1988.

#### Commencement

2. These Regulations come into operation on 14 December 1988.

#### Authority

3. These Regulations are made under the powers in section 9 of the *Melbourne Cricket Ground Act 1933*.

#### Principal Regulations

4. In these Regulations the regulations made by the trustees and notified in the *Government Gazette* on 27 March 1907, and continued in force by the *Melbourne Cricket Ground Act 1933*\* are called the Principal Regulations.

#### Regulation 17 Substituted

5. For Regulation 17 of the Principal Regulations substitute—

#### Offences

"17. (1) A person must not—

- (a) in attempting to enter the Reserve or whilst in the Reserve, use obscene, indecent, abusive, insulting or threatening language; or
- (b) in attempting to enter the Reserve or while in the Reserve, assault a person or behave in an improper or riotous manner; or
- (c) enter the Reserve if the person is drunk; or
- (d) trespass or (without the authority of the trustees or their servant or agent) cross the playing ground—
  - (i) during a cricket or football match or other outdoor game, sports amusements, parade or display; or
  - (ii) during practice at cricket; or
  - (iii) when that crossing or trespassing would damage the ground as a cricket ground; or
- (e) enter or remain in the first or third division of the Reserve, if the person has been required by a gatekeeper or other person authorised by the trustees to produce or surrender a ticket entitling the person to enter that division and does not do so; or
- (f) obtain admission to a division of the Reserve without being entitled to be admitted in accordance with these Regulations.

(2) The trustees or their servant or agent may refuse admission to the Melbourne Cricket Ground to a person if the trustees believe, or the servant or agent believes, on reasonable grounds that the person has committed or is attempting to commit a contravention of sub-regulation (1) or an offence under the *Liquor Control Act 1988*.

(3) A person may be refused admission under sub-regulation (2) even though the person has a ticket entitling the person to admission to the ground."

Title

1. These Regulations may be cited as the Melbourne Cricket Ground (Liquor Control) Regulations 1988.

Commencement

2. These Regulations come into operation on 14 December 1988.

Authority

3. These Regulations are made under the powers in section 9 of the *Melbourne Cricket Ground Act 1933*.

Principal Regulations

4. In these Regulations the regulations made by the trustees and notified in the *Government Gazette* on 27 March 1907, and continued in force by the *Melbourne Cricket Ground Act 1933*\* are called the Principal Regulations.

Amendment of Regulation 17

5. Regulation 17 of the Principal Regulations is amended as follows:

- (a) In sub-regulation (1) (c) after "enter" insert "or remain in".
- (b) In sub-regulation (1) after paragraph (f) insert—  
"or
- (g) bring or attempt to bring liquor into the Reserve; or
- (h) consume liquor in, or bring or attempt to bring liquor into, an area in the Reserve specified as a dry area

by notice placed by the trustees at each usual entrance to the area; or

- (i) in the Reserve, consume, or have in possession or under control, liquor except liquor obtained by that person—

- (i) in a sealed container, bottle or can; and

- (ii) from licensed premises in the reserve where the licensee is authorised to sell liquor for consumption off the premises.";

- (c) After sub-regulation (3) insert—

- '(4) Sub-regulation (1) (i) does not apply to licensed premises within the meaning of the *Liquor Control Act 1987*.

- (5) In sub-regulation (1) "licensed premises" and "liquor" have the same meanings as in the *Liquor Control Act 1987*."
