HORSHAM PLANNING SCHEME

Notice of Approval of Amendment

Amendment L10

The Minister for Planning and Environment has approved Amendment L10 to the Horsham Planning Scheme.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment introduces a definition of Supermarket and makes it subject to permit in the Commercial A and C Zones and prohibited in all other zones. The amendment also corrects minor errors in the Scheme.
