Subordinate Legislation Act 1962 PROPOSED FISHING (SCALLOP)

(AMENDMENT No. 1) REGULATIONS 1988

Notice is hereby given that a Regulatory Impact Statement has been prepared in relation to the Fishing (Scallop) (Amendment No. 1) Regulations 1988.

The purpose of the proposed Regulations is to open the season for the taking of scallops within certain boundaries in Eastern Victorian waters and to change the catch limit for the taking of scallops in Victorian waters other than Port Phillip Bay. The objective is to achieve rational exploitation of Victoria's scallop resources.

The Regulatory Impact Statement concludes that management of scallop beds by the use of closed seasons is an effective conservation technique, and that Regulations are required to enforce observance by all fishermen.

Copies of the Regulatory Impact Statement and proposed Regulations may be obtained from Mr F. Forte, Economics Branch, Department of Conservation, Forests and Lands, 240 Victoria Parade, East Melbourne (telephone (03) 412 4588).

Public comments are invited on the Regulatory Impact Statement and proposed Regulations. Written submissions will be received at the above address up to 21 days from the date of publication of this notice. All submissions will be treated as public documents.

FRIENDLY SOCIETIES ACT

i, Robert Allen Jolly, Treasurer of the State of Victoria, pursuant to section 66 (1) (i) of the Friendly Societies Act, approve a friendly society entering into approved financial instruments subject to the conditions set out below.

Approved Financial Instruments

The following financial instruments are approved financial instruments for the purposes of this approval:

A futures contract or an option on a futures contract for the purchase or sale of:

- (a) bank accepted bills of exchange; or .
- (b) Treasury bonds; and

A futures contract for the payment or receipt of money calculated by reference to movement in the all ordinaries share price index and an option on such contract.

Conditions

A friendly society may enter into approved financial instrument subject to the friendly society complying with the following conditions:

- 1. The approved financial instrument if traded, must be traded on the Sydney Futures Exchange and the counterparty for exchange raded business must be a recognised full member of the Sydney Futures Exchange and a recognised options dealer of the Sydney Futures Exchange.
- 2. A friendly society may only enter into an approved financial instrument if it is being entered into for the purpose of investing the monies standing to the credit of a fund established after the date hereof and the fund has—
 - (a) rules which expressly state the intention and the manner in which the approved financial instrument will be used; and
 - (b) has a benefit level which has been approved on the basis that the monies standing to the credit of the fund will be invested in a class of investments which include approved financial instruments.
 - 3. A friendly society must ensure that-

 - (b) where it enters into one or more approved financial instruments which have a short position the dollar face value of the exposure of the friendly society under those instruments, must not exceed the current value of relevant physical securities standing to the credit of the fund in respect of which the approved financial instruments were entered into.

- 3. The value of the assets of the corporation has at all times during the period of two years prior to the date on which the investment was made been one and a half times the value of its liabilities.


