(iii) \$60 for any other licensed race meeting.

(b) Wherever, in accordance with plans submitted by the club and approved by the Executive Council under section 5 of the *Racing Act 1958*, there is provision for Rails Bookmakers, any person desiring to carry on the business or vocation of a Rails Bookmaker, must pay an additional fee (known as a "rails fee") not exceeding—

#### NOTICE OF AMENDMENT TO A PLANNING SCHEME

The Shire of Talbot and Clunes has prepared amendment L1 to the Talbot and Clunes Planning Scheme.

The amendment affects the Township Zone by limiting the existing as-of-right provisions for detached houses, so that they will apply only to areas which are developed with sealed roads and services of water supply, electricity and drainage. As a result, in other areas which are not so developed, a detached house would be made a discretionary use.

It also affects the Low Density Residential Zone by providing Council with discretionary power, to enable it to consent (in isolated deserving cases) to the construction of a detached house on an existing tenement of less than 0.2 hectares.

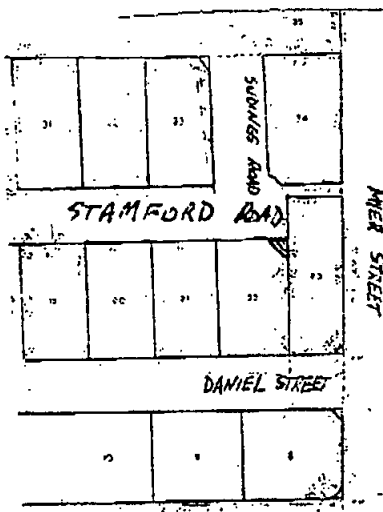
