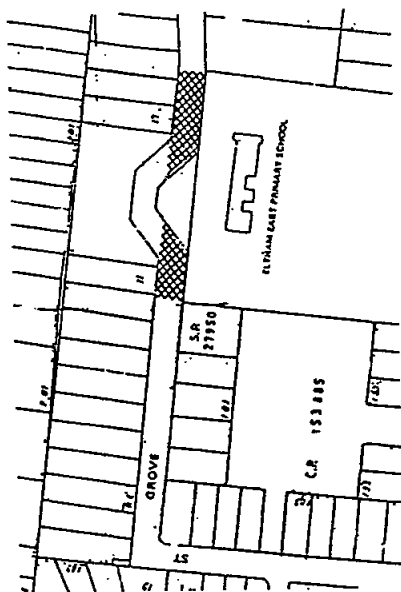

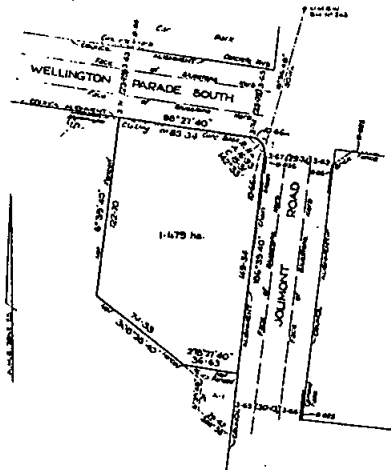

Tenders are to be received no later than 4.00 p.m. on 19 October 1988. Addressed to the Director, Victorian Government Major Projects Unit, 176 Wellington Parade, East Melbourne and lodged in the Tender Box located at the 4th Floor, 176 Wellington Parade, East Melbourne.

Property Address and Description: Corner of Wellington Parade South and Jolimont Road, Jolimont being all that piece or parcel of land in the Parish of North Melbourne, County of Bourke, depicted on the plan hereunder comprising an area of 1.479 hectares.



Tender Process and Terms of Sale: The land described is to be sold by way of a two stage tender process. In stage one, prospective purchasers are asked to submit a firm and binding offer to purchase the land and develop it for a public car park and commercial and residential complex.

From the offers submitted in stage one, up to 5 tenderers will be invited to prepare detailed development proposals for the land in stage two of the tendering process. Upon acceptance of an invitation, stage two tenderers will be required to lodge a performance bond in the form of a Bank Guarantee to the value of \$100 000. The successful tenderer will need to satisfy the Government's financial, urban design and development objectives for the land. 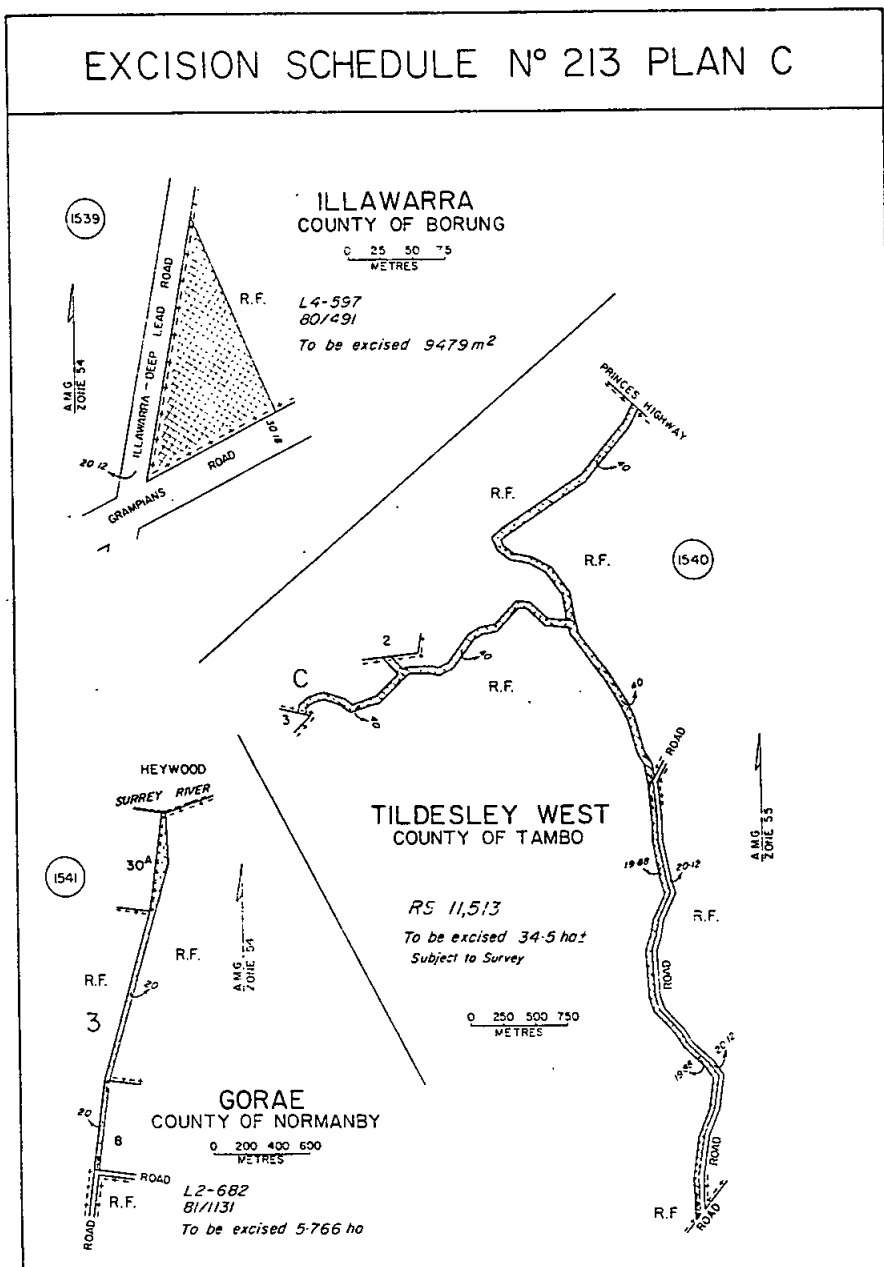
EXCISION SCHEDULE N° 213 PLAN A



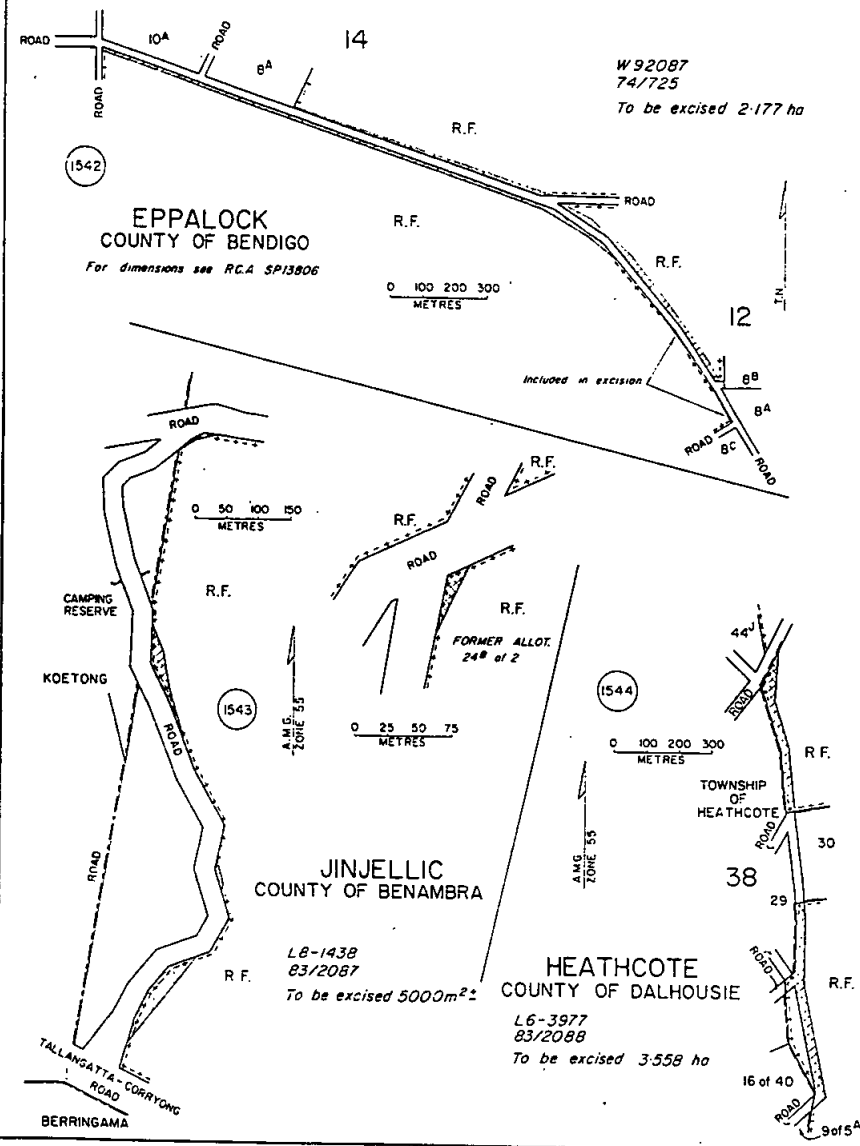
EXCISION SCHEDULE N° 213 PLAN B



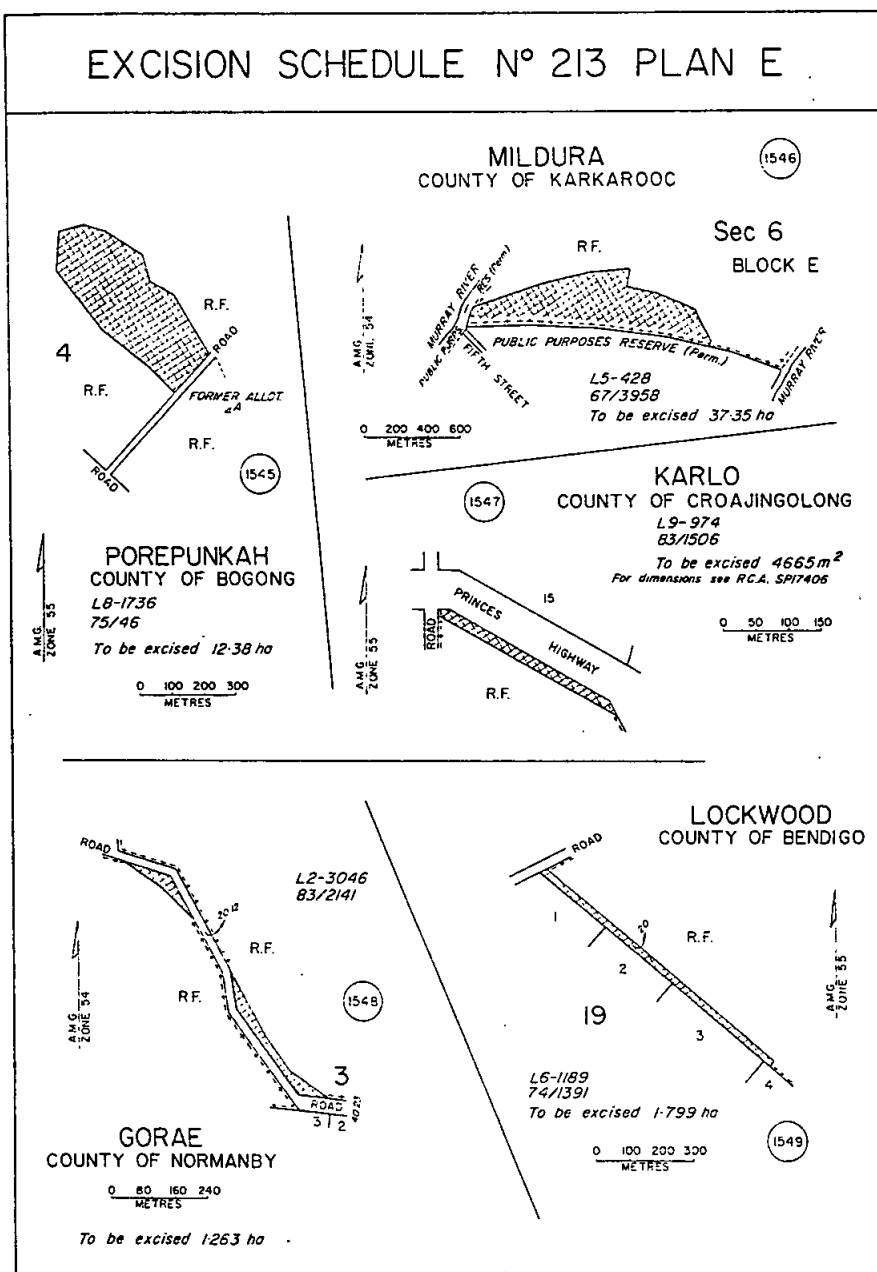
EXCISION SCHEDULE N° 213 PLAN C

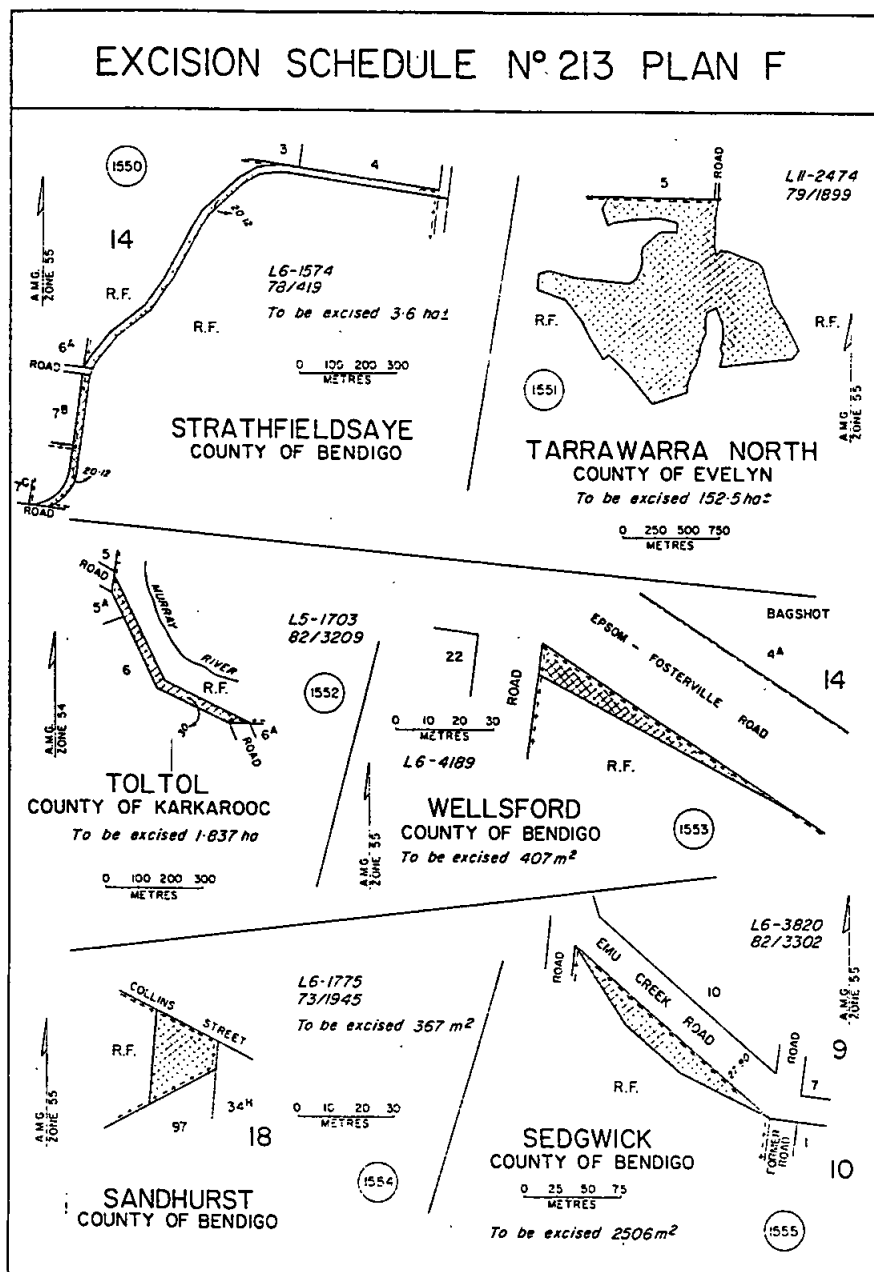


EXCISION SCHEDULE N° 213 PLAN D
