FIGURE 1: ZONE 1 (INCLUDING BUILT-UP AREAS)

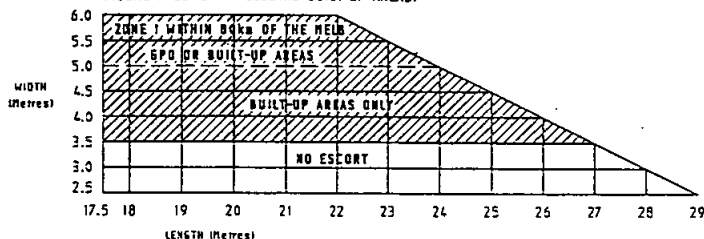


FIGURE 2: ZONE 2 (INCLUDING BUILT-UP AREAS)

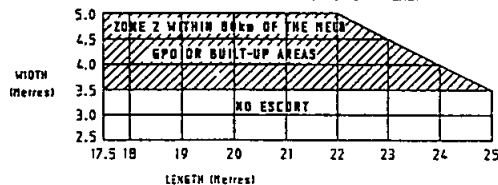


FIGURE 3: RESTRICTED ROADS

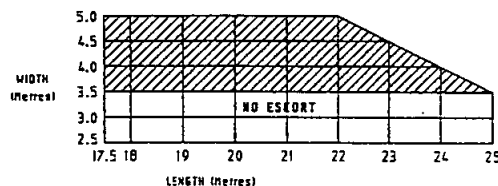
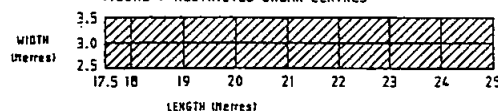


FIGURE 4: RESTRICTED URBAN CENTRES
