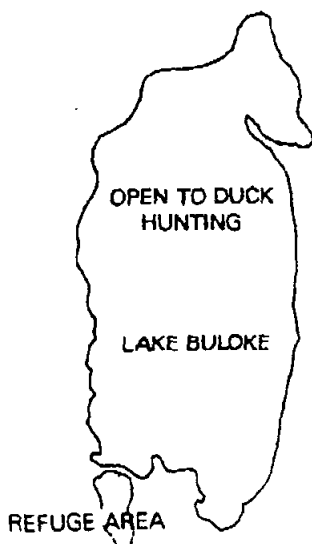
NOTICE OF CLOSURE OF LITTLE LAKE BULOKE TO HUNTING

I give notice under section 86 of the *Wildlife Act 1975* that—

- (a) the taking, destroying or hunting of any kind or species of wildlife is prohibited in the area described in the Schedule during the period beginning on Saturday, 8 April 1989 and ending on Sunday, 9 April 1989;
- (b) a person who takes, destroys or hunts any kind or species of wildlife in that area during that period is guilty of an offence and liable to a penalty not exceeding \$200.

Schedule

Little Lake Buloke, Shire of Donald, which includes all of the public land south of the point known as "the Neck" which separates Little Lake Buloke from Lake Buloke.
