**TOMATO PROCESSING INDUSTRY
(AMENDMENT) REGULATIONS 1989**

Notice of Regulatory Impact Statement

It is proposed to amend the Tomato Processing Industry Regulations 1979 to enable tomato processors to purchase tomatoes on the basis of the soluble solids content of the tomatoes.

A Regulatory Impact Statement has been prepared in accordance with the requirements of the *Subordinate Legislation Act 1962* and concludes that the tomato processing industry in Victoria will benefit from improved competitiveness following from the introduction of a contract option for the purchase of processing tomatoes, on the basis of soluble solids.
