**Notice of Approval  
Amendment R66**

The Minister for Planning and Environment has approved Amendment R66 to the Metropolitan Region Planning Schemes.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment applies to specific properties in the City of South Melbourne—

4-6 Bowen Crescent  
400 St Kilda Road  
414-416 St Kilda Road  
576-578 St Kilda Road

The amendment allows permit applications to be considered for development which would otherwise exceed the height and plot ratio restrictions but only within specified limits for each property. These provisions will cease to apply after 31 December 1990.

The amendment also corrects an error concerning four properties listed in the Table to Division 3e which are in the City of St Kilda but were identified as being in the City of South Melbourne.

A copy of the amendment can be inspected, free of charge, during office hours at the Ministry for Planning and Environment, The Olderfleet Buildings, 477 Collins Street, Melbourne and at each municipal office in the Metropolitan Region.
