Notice of Approval of Amendment  
Amendment RL127

The Minister for Planning and Environment has approved Amendment RL127 to the Regional Section of all Planning Schemes in the Metropolitan Region and the Local Section of the Port Melbourne and South Melbourne Planning Schemes.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment introduces a new overlay planning control to ensure that the redevelopment of the Docklands-Victoria Harbour site is not prejudiced by the inappropriate use or development of nearby land. Applications for permits in this area will be required to be referred to the Minister for Planning and Environment under section 55 of the Act.

A copy of the amendment can be inspected, free of charge, during office hours, at the Ministry for Planning and Environment, Ground Floor, 477 Collins Street, Melbourne; the City of Port Melbourne, Municipal Offices, Bay Street, Port Melbourne, and the City of South Melbourne, Municipal Offices, Bank Street, South Melbourne.

The Regional Section of the amendment can be inspected at the offices of each municipality in the Metropolitan Region.
