Amendment L16

The Minister for Planning and Environment has approved Amendment L16 to the Local Section of the Knox Planning Scheme.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment rezones land on the north side of Ferntree Gully Road, west of Stud Road, Scoresby, and forms part of the Scoresby Village shopping centre. It modifies zone and reservation boundaries for Car Parking, Church and Religious Organisation and Public Open Space.
