ENVIRONMENT EFFECTS STATEMENT

VIC ROADS has been investigating the location and form of the Western Ring Road (WRR) from Laventon North to Tullamarine and has prepared the Environment Effects Statement (EES). The project will improve road access within the western suburbs and link major radial routes including Princes Freeway, Western Highway, Calder Freeway and Tullamarine Freeway.

The preferred location for the WRR is generally along the existing proposed main road reservation for F3-F5 included in the planning schemes of the Cities of Werribee, Sunshine and Keilor. The main changes to the current reservation are proposed at:

- Ardeer, where the proposed reservation is located west of Ardeer rather than alongside the SEC transmission lines.
- Albion North, where the reservation at Furlong Road is proposed 20 m further from nearby houses.
- East Keilor, where it is proposed to reserve additional land for an interchange between the WRR and the Calder Freeway.
- East Keilor, where a new link road is proposed between Keilor Park Drive and Milleara Road.
- Tullamarine, where a new link road to Melbourne Airport is proposed.

The Minister for Planning and Environment has prepared the above amendments to Planning Schemes, which provide for the future construction of the Western Ring Road between Laverton North and Tullamarine.

The amendments include:

- a new road reservation route to the west of Ardeer.
- · rezoning of the previous road reservation through Ardeer.
- reservation for a future interchange between the WRR and the Calder Freeway.
- reservation for a future additional access to Melbourne Airport.
- minor modifications to existing road reservations.
- various rezonings of land in the vicinity of the WRR.

Following the public exhibition period and receipt of submissions, the Minister for Planning and Environment may appoint an independent panel at which persons may be heard in respect of individual submissions. Persons lodging submissions should state whether or not they wish to be heard at the panel hearing.

The persons appointed to any panel by the Minister for Planning and Environment will provide a report on the EES and the Planning Schemes Amendments to the Minister, who in turn will provide an assessment of the environmental effects to the Minister for Transport.
