







In pursuance of the powers conferred by section 76 of the *Co-operation Act 1981* ("the Act") I, Andrew McCutcheon, Attorney-General, after consultation with the Credit Co-operatives Reserve Board hereby determine that a credit society registered under the Act may invest any portion of its funds not immediately required for its objects or for purposes incidental to those objects in the following manner:

Victoria Government Gazette

- A. (i) In any manner in which a trustee is authorised under the law of Victoria to invest trust funds in accordance with and subject to the limitations of Part I of the *Trustee Act 1958* except those investments contained in the provisions of sub-sections 4 (1) (f), 4 (1) (g) and 4 (1) (r) of that Act.
- (ii) On deposit with the Victorian Credit Co-operative Association Limited.
- (iii) In bills of exchange accepted by a member of the Australian Merchant Bankers Association.
- (iv) On deposit with, or in any securities issued, by a wholly owned subsidiary of a bank.
- (v) On deposit with unofficial money market dealers providing such deposits are secured either as per paragraph (iii) of this Determination or as per sub-sections 4 (1) (a) to 4 (1) (k) and 4 (1) (m) to 4 (1) (p) of the *Trustee Act 1958*.
- (vi) On the security of a first mortgage of freehold land registered under the *Transfer of Land Act 1958*, but not the security of a second mortgage or a mortgage of an equity of redemption or other equitable interest in land, provided that:
- (a) in making the investment, the credit society was acting upon a report as to the value of the property made by a person who was the holder of certificate of qualification as a valuer under the *Valuation of Land Act 1960* instructed and employed independently of any owner of the property, whether such valuer carried on business in the locality where the property is situate or elsewhere, and
- (b) the amount of the investment did not exceed two-thirds of the value of the property as stated in the report, and
- (c) the investment was made under the advice of the valuer, expressed in the report,
- (d) the amount of the investment under this paragraph does not exceed 20 per cent of the realised reserves of the credit society as at the commencement of the financial year of the credit society.
- Provided that any investment referred to in paragraphs (i)-(iv) hereof shall not be for a term exceeding 36 months.

B. In addition to those investments listed in paragraph A hereof, a credit society may, based on the level of its realised reserves as illustrated

in the following table, invest its funds in any manner whatsoever except in the purchase of shares in a corporate body or the investment of funds in a company which is associated or related to the credit society provided that the value of such investments made pursuant to this power does not exceed the maximum level of investment shown in the table as corresponding to each level of realised reserves:

Realised Reserves (Percentage of total assets at commencement of financial year)	Maximum Level of Investment Percentage of total depositors' balances at commencement of financial year)
Less than 3 %	Nil
3% to less than 5%	2%
5% to less than 7%	4%
7% or more	6%

For the purpose of this Determination:

"Bank" means the State Bank of Victoria, and any other body corporate defined as a bank by section 5 (1) of the Banking Act 1959-73 of the Commonwealth, which carries on business in Victoria.

"Wholly Owned Subsidiary of a Bank" means a wholly owned subsidiary of a "Bank" as defined above, which carries on business in Victoria.

"realised reserves" means reserves appropriated from the surplus of a credit society and includes unappropriated profits. Surplus does not include:

- a capital profit arising from an assessment of the value of an asset in excess of its cost value;
- the amount by which the revenue of the credit society has increased due to the inclusion of the amount of any anticipated tax benefit.

"depositors' balances" means the total of all deposits of a credit society excluding accrued interest in the latest balance sheet of the credit society lodged with the Registrar of Co-operative Societies in accordance with section 147 (2) of the *Co-operation Act 1981*.

"total assets" means the value of the assets of a credit society in the latest balance sheet of the credit society lodged with the Registrar of Co-operative Societies in accordance with section 147 (2) of the *Co-operation Act 1981*.





PROCLAMATION OF SHEPPARTON TAXI-CAB ZONE AND SPECIFICATION OF LICENSING PROCEDURES

The Administrator in Council under section 143A of the *Transport Act 1983* by this Order—

1. proclaims the area within an 8 kilometre radius of the post office at Shepparton as a taxi-cab zone to be called the "Shepparton Taxi-cab Zone";

2. specifies that the fee to be paid for a taxi-cab licence in the Shepparton Taxi-cab Zone shall be determined by tender;

3. specifies that people eligible to tender for the granting of a taxi-cab licence to operate in the Shepparton Taxi-cab Zone are:

- (ii) have driven Taxi-cabs in the Shepparton area; and
- (iii) are under the age of 62 years on 31 May 1989; or

(b) companies, at least one director of which satisfies the requirements of clause (3) (a) (i), (ii) and (iii).

4. specifies the following procedures for the granting of taxi-cab licences in the Shepparton Taxi-cab Zone—

(a) the Road Traffic Authority must conduct a review of taxi operations at Shepparton and must make the results of that review available to interested persons on request not later than 31 August 1989;

(b) a tender and application in a form provided by the Road Traffic Authority must be duly completed by the applicant, sealed in an envelope and submitted to the Authority's Vehicle Licensing Branch, 2nd Floor, corner Lygon and Princes Streets, Carlton not later than 4.00 p.m. on 15 September 1989;

(c) the tender and application must contain the following particulars—

- an indication that the application relates to the Shepparton Taxi-cab Zone;
- the name, address and date of birth of the applicant or in the case of a company, a copy of the certificate of incorporation and the names, addresses and dates of birth of its directors;
- the amount tendered as the licence fee;
- a description of the vehicle;

the address from which the vehicle is to operate;

details of the driver's certificate held by the applicant or director of the applicant company as the case may be, including date of issue, classification and expiry date; a declaration of the applicant's, or in the case of a company, the director's taxi-cab driving experience within the area specified in clause 1;

(d) the Authority must—

(i) if the Authority determines that one licence should be issued, issue the licence to the person who meets the eligibility criteria, and submits the highest tender;

(ii) if the Authority determines that more than one licence should be issued, issue the licences to the person or persons who meet the eligibility criteria in the descending order of highest tenders; and

(iii) if tenders of identical value are submitted, issue the licence to the applicant with the longest aggregate period of taxi-cab driving experience within the area specified in clause 1. If the applicant is a company, the taxi-cab driving experience of the director with the greatest taxi-cab driving experience shall be used to determine the order of licence issue.

5. declares that all applications for taxi-cab licences to operate in the Shepparton Taxi-cab Zone lodged prior to the date of this Order shall lapse.






