

EXEMPTION

Application No. 6 of 1989

On 26 September 1989 the Equal Opportunity Board considered an application pursuant to section 40 (1) of the Equal Opportunity Act 1984 ("the Act") by the Annie North Refuge Collective Inc. ("the Collective").

Upon reading the material tendered in support of this application and hearing submissions on its behalf from Ms. Julie Hughes, Member of the Collective, the Board is satisfied that it is appropriate to grant an exemption from sections 21 and 59 of the Act in the application to both membership and employment with the Collective where the actions taken by the Collective may be said to be in pursuance of the following purposes:

To provide, develop and extend supported accommodation together with relevant support services for women and their dependent children who are leaving or attempting to leave situations of domestic violence and other forms of assault and abuse against them.

To provide support, information, referrals and care to women who are survivors of assault and other forms of abuse through the provision of non-clinical, community based, women-centred services.

To develop links with other community agencies/services particularly those specialising in womens and/or accommmodation services through regular contact, attending relevant meetings, for example: Y.W.C.A., womens health project, M.O.H.C., L.C.Y.A.C., R.H.C., etc.

To undertake to provide education in the community aimed at changing society attitudes, structures and institutions which support and perpetuate domestic violence and other forms of abuse and assault against women and children by:

providing speakers for community meetings and workshops.

producing and disseminating educational material, e.g. pamphlets, posters.




