VARIATION OF FIRE DANGER PERIOD

In pursuance of the powers conferred by section 4 of the *Country Fire Authority Act 1958*, Kevin Patrick Shea, Chairman of the Country Fire Authority, after consultation with the Director-General of Conservation, Forests and Lands, hereby vary the declaration of Fire Danger Periods previously published in the *Government Gazette* by declaring that such fire danger periods shall end in respect of the undermentioned municipalities or parts of municipalities specified.

REVOCATION OF PROHIBITED PERIOD

In pursuance of the powers conferred by section 3 of the *Forests Act 1958*, I, Steve Crabb, Her Majesty's Minister for Conservation and Environment in the State of Victoria, hereby vary the Declarations of a Prohibited Period previously made by me in the *Victoria Government Gazette* No. 49 dated 13 December 1989 insofar as they refer to the municipalities specified hereunder, and by this notice declare that in the specified municipalities the Prohibited Period in respect to any fire protected area (other than a State forest, National park or Protected public land) shall end as specified hereunder.

Schedule 1

The Prohibited Period shall end at 0100 hours on Saturday, 21 April 1990 in the following municipalities:

The Shires of Beechworth, Benalla, Bright, Chiltern, Euroa, Healesville, Myrtleford, Pakenham, Tallangatta, Upper Murray, Upper Yarra, Violet Town, Wangaratta and Yackandandah;

The Rural City of Wodonga.
