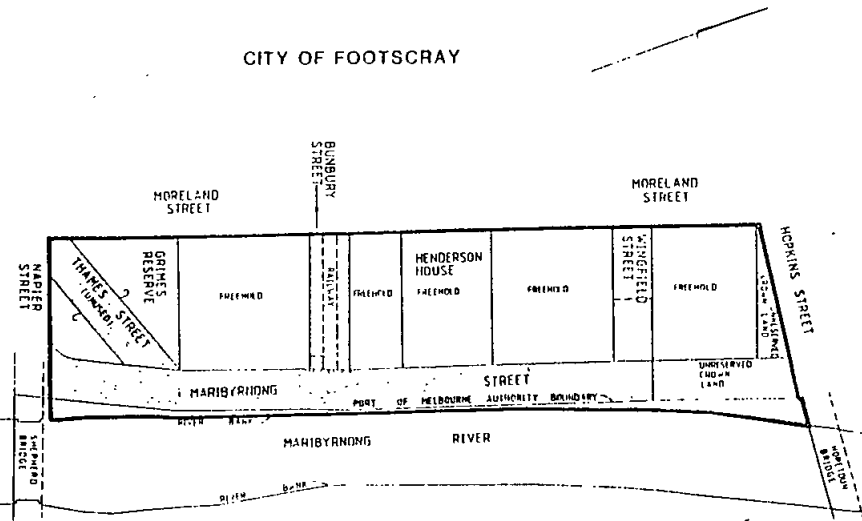

Planning and Environment Act 1987

DECLARATION UNDER SECTION 172 (2)

Being satisfied that to enable the better use, development or planning of the area, the land bounded by Moreland Street, Hopkins Street, Napier Street and the Maribyrnong River within the City of Footscray and as shown on the accompanying map, it is desirable that the City of Footscray as the Responsible Authority, compulsorily acquire the land in the area.
