ROAD SAFETY (BICYCLE HELMETS)  
REGULATIONS 1990

Notice is given of the proposal to make regulations to be known as the Road Safety (Bicycle Helmets) Regulations 1990.

A regulatory impact statement has been prepared as required by the *Subordinate Legislation Act 1962*.

The objective of the proposed regulations is to reduce head injury and brain damage to cyclists involved in accidents.

The regulatory impact statement concludes that the proposed regulations provide the most cost-effective means of achieving the objective.
