FISHERIES NOTICE  
No. 2/1990

I, Steven Crabb, Minister for Conservation and Environment, after consultation with the Victorian Fishing Industry Federation, make the following Fisheries Notice:

FISHERIES (SCALLOP FISHING—  
PROHIBITION) NOTICE 1990

*Title*

1. This Notice may be cited as the Fisheries (Scallop Fishing—Prohibition) Notice 1990.

*Objective*

2. The objective of this Notice is to prohibit the taking of scallops or the use of any scallop dredge in Victorian waters between 146 degrees and 148 degrees east longitude.

*Authorising Provision*

3. This Notice is made under section 80 of the *Fisheries Act 1968*.

*Prohibition of Dredging or the Taking of  
Scallops*

4. A person must not—

- (a) take any scallops; or
- (b) use any scallop dredge—

in Victorian waters between 146 degrees and 148 degrees east longitude during the period commencing on 25 July and ending on 24 October 1990.

*Penalty*

5. Any person who contravenes this Notice is liable to a penalty of 20 penalty units.
