*Liquor Control Act 1987*

PROCLAMATION

Authorisation enabling Packaged Liquor Bottle  
Shops to trade on four ordinary closing days  
within the meaning of the *Shop Trading Act*  
1987

I, J. Davis McCaughey, Governor of Victoria,  
acting with the advice of the Executive Council  
and under sections 51 (1) (d) and 51 (1A) of the  
*Liquor Control Act 1987*, by this proclamation  
authorise licensees who hold a Packaged Liquor  
Licence or a licence which has effect as a Packaged  
Liquor Licence, to sell and dispose of liquor at  
any time after 10.00 a.m. and before 5.00 p.m.,  
on the following ordinary closing days:

Sunday 2 December 1990

Sunday 9 December 1990

Sunday 16 December 1990

Sunday 23 December 1990.
