DECLARATION OF PROHIBITED PERIOD

In pursuance of the powers conferred by section 3 of the *Forests Act 1958*, I, Rod Incoll, delegated officer for Her Majesty's Minister for Conservation and Environment in the State of Victoria, hereby declare a Prohibited Period in respect of any fire protected area (other than State forest, national park and protected public land) at the times, dates and in the municipalities specified in Schedules 1 and 2 hereunder:

Schedule 1

The Prohibited Period shall commence at 0100 hours on Saturday, 22 December 1990 and end at 0100 hours on Wednesday, 1 May 1991 (unless varied), in the municipalities shown hereunder:

The Shires of Bellarine, Bannockburn, Barrabool, Colac, Corio, Gisborne, Heytesbury, Leigh, Newham and Woodend, Otway, Romsey and Winchelsea.

The City of Barwon.

Schedule 2

The Prohibited Period shall commence at 0100 hours on Saturday, 5 January 1991 and end at 0100 hours on Wednesday, 1 May 1991 (unless varied), in the municipalities shown hereunder:

The Shires of Mirboo, South Gippsland and Woorayl.
