## RURAL WATER COMMISSION OF VICTORIA

By-Law No. 6158

Amending By-law No. 6056 as amended by By-law Nos 6103, 6105 and 6132 for Regulating Shooting on Commission Property During the Declared Open Season for Shooting of Wild Ducks.

The Rural Water Commission of Victoria (hereinafter called "the Commission"), pursuant to the provisions of the *Water Act* 1958 and all other powers enabling it in that behalf, makes the following By-law:

1. By-law No. 6056 made by the Commission on 20 February 1986 (and amended by By-law No. 6103 made by the Commission on 24 February 1988, By-law No. 6105 made by the Commission on 15 June 1988 and By-law No. 6132 made by the Commission on 16 February 1989) is hereby amended as follows:

In Schedule 1—

- (a) delete "Green and Dock Lakes" and insert "Dock Lake";
- (b) delete "Lake Mokoan".

The foregoing By-law was made by the Rural Water Commission of Victoria on 1 March 1990, and the Seal of the Commission was hereunto affixed on 1 March 1990 by the Authority of the Board.
