Bees Act 1971

PROCLAMATION

Proclaimed Area in the Shire of Bulla

I, Sir John McIntosh Young, Lieutenant-Governor of Victoria acting with the advice of the Executive Council and under section 4 of the *Bees Act 1971*—

1. declare the portion of Victoria defined in the Schedule, being an area where disease exists, to be a proclaimed area for the purposes of the Act; and

2. prohibit the sending or bringing of bees, honeycomb, hives or appliances into the proclaimed area or the sending or removal from the proclaimed area into any other part of Victoria of bees, honeycomb, hives or appliances unless approved by an apiary inspector.

SCHEDULE

The portion of Victoria within the Shire of Bulla bounded by a line commencing at the intersection of Somerton Road and Mickleham Road, then in a southerly direction along Mickleham Road to Swain Street, then in a westerly direction along Swain Street to a point where Swain Street meets the boundary of the Gellibrand Hill Park, then in a westerly direction along the Gellibrand Hill Park boundary to the Greenvale Geriatric Centre reserve, then in a westerly and northerly direction along the Greenvale Geriatric Centre reserve, then in a northerly direction along the Gellibrand Hill Park boundary to Somerton Road, then along Somerton Road in an easterly direction to the point of commencement.

FISHERIES NOTICE No. 5/1990

I, Steven Crabb, Minister for Conservation and Environment, after consultation with the Victorian Fishing Industry Federation, make the following Fisheries Notice:

FISHERIES (SCALLOP FISHING) (No. 2) NOTICE 1990

TITLE

1. This Notice may be cited as the Fisheries (Scallop Fishing) (No. 2) Notice 1990.

COMMENCEMENT

2. This Notice comes into operation on 4 November 1990.

OBJECTIVES

3. The objectives of this Notice are to—
 - (a) extend the open season for scallop dredging in Victorian waters, other than Port Phillip Bay; and
 - (b) control the level of exploitation of scallop stocks by fixing a weekly catch limit for the taking of scallops.

AUTHORISING PROVISION

4. This Notice is made under section 80 of the *Fisheries Act 1968*.

REVOCATIONS

5. Fisheries Notice No. 3/1990 is revoked.

DEFINITIONS

6. "Act" means the *Fisheries Act 1968*.
"Authorised officer" means an authorised officer appointed under Part 9 of the *Conservation, Forests and Lands Act 1987*.
"Crate" means a wire mesh container with external dimensions not exceeding 100 centimetres by 50 centimetres by 50 centimetres and constructed as specified in the diagrams in Form 1 in the Schedule to this Notice.
"Crate tag" means a tag as specified in the diagram in Form 2 in the Schedule to this Notice.

OPEN SEASON

7. Subject to section 15 (1) (h) of the Act the holder of a scallop licence may dredge for or take scallops for sale from Victorian waters, other than Port Phillip Bay, during the period commencing 4 November 1990 and ending on 22 December 1990.

CATCH LIMITS

8. A master fisherman operating a registered fishing boat for which a scallop licence has been issued must not take from that boat from Victorian waters more than ten crates of scallops during a seven-day period commencing on each Sunday of the open season.

TAGGING OF CRATES

9. Every holder of a scallop licence permitting the dredging or taking of scallops in any Victorian waters other than Port Phillip Bay may on production of his or her scallop licence make application to an authorised officer for an allocation of the number and colour of crate tags prescribed in the Table to this clause for the period prescribed in the Table to this clause.

10. (1) Crate tags are only valid for the period set out against the crate tag colour in the Table to Clause 9 of this Notice.

(2) Crate tags will be serially numbered and may only be used to secure crates on the licensed scallop boat for which the crate tags were allocated by the authorised officer.

11. A person in charge of a boat shall ensure that—

- (a) in respect of scallops taken from Victorian waters other than Port Phillip Bay that those scallops are not contained on board or landed in any container other than a crate;
- (b) while a registered fishing boat for which a scallop licence has been issued is on the Gippsland Lakes or Corner Inlet all full or partly filled crates of scallops on board the boat must be secured with a crate tag in such a manner that the lid of the crate cannot be opened without cutting or breaking the tag;
- (c) when a crate containing scallops is landed that each crate lid is closed and secured with a crate tag so that the crate lid cannot be opened without cutting or breaking the crate tag.
- (d) when a crate containing scallops is landed the crate lid is so closed and secured with a crate tag until the scallops are to be removed from the crate at a fish processing premises specified in a processors licence;
- (e) crate tags are not transferred to any other person; and
- (f) crate tags are not re-used.

PENALTY

12. Any person who contravenes this Notice is liable to a penalty of 20 penalty units.

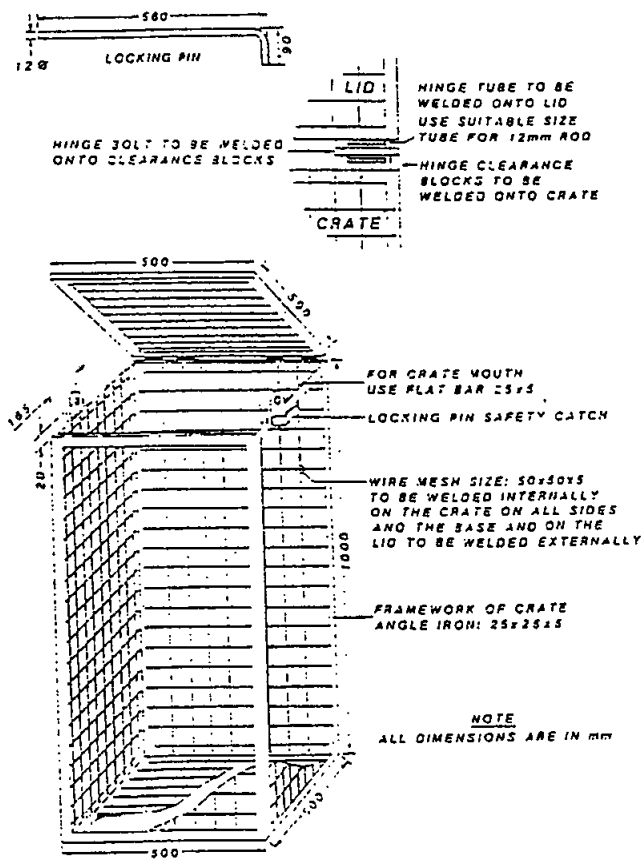

Form 1

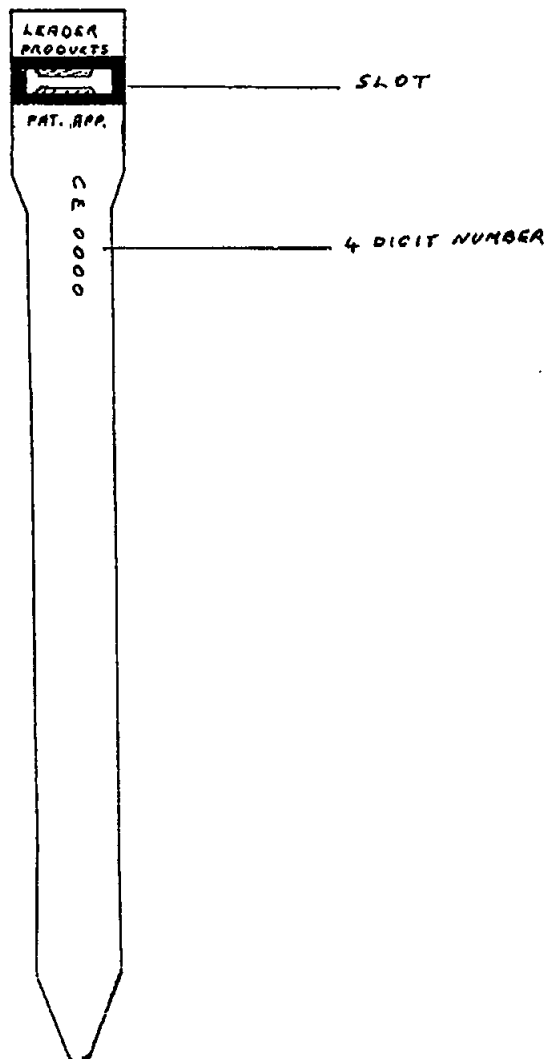
Construction of Crate

**FISHING (SPINY FRESHWATER
CRAYFISH) REGULATIONS 1990**

A Regulatory Impact Statement has been prepared in relation to the proposed Fishing (Spiny Freshwater Crayfish) Regulations 1990.

The principal objective of the Regulations is to maintain viable stocks of Spiny Freshwater Crayfish whilst maintaining a satisfactory recreational fishing experience for users of the Spiny Freshwater Crayfish resource.

The Regulatory Impact Statement concludes that the best means of achieving the objective is to make regulations which will remove existing restrictions on closed waters, impose a minimum size limit for species of crayfish and halve the bag limit for one species (Glenelg Spiny Crayfish), affording that species some special protection.

Two alternatives of either maintaining existing restrictions or removing current closures without imposition of a size limit were considered and rejected, the first on the basis that it imposed unnecessary restrictions on recreational anglers, and the latter on the basis that it was likely to

over-exploit the resource. For these reasons it was considered that the alternatives could not achieve the stated objective.

Water Rating By-Law for the Year 1990-91

Water Supply By-Law No. 12

The Municipal Council of the City of Warrnambool in pursuance of an in exercise of the powers conferred by the *Water Act* 1958, hereby makes a By-law as follows—

1. This By-law shall have effect as from the commencement of the meter year for the financial year commencing on 1 October 1990.

2. The meter or meters measuring the supply of water to any land or tenement shall be read as near as practicable to twelve months from the date that it was read previously and the quantity of water so measured as having been supplied during the period between any two successive such readings (hereinafter called "the meter year") shall be the basis of the calculating of charges payable under this By-law provided always that where a meter has been measured as having been supplied during the period between the date of such installation and the date of the reading shall be the basis of calculating such charges.

3. Subject as is hereinafter provided in respect of any land or tenement by the Council:

(a) The maximum quantity of water to be supplied in any meter year without charge is hereby fixed as a quantity which, if charged at 66 cents per kilolitre for any meter year, would give an amount equal to the amount of the rate payable in respect of the land or tenement for the financial year in which the said meter year ended;

(b) For all water supplied in any meter year in excess of the maximum quantity referred to in paragraph (a) of this clause, the charge is hereby fixed at 66 cents per kilolitre for any meter year.

4. Subject as is hereinafter provided, the charge for water supplied by measure to any property not rated by the Council is hereby fixed at 66 cents per kilolitre.

5. The minimum charge for water supplied by measure to any property not rated by the Council is hereby fixed at \$140.

6. The aforesaid charges shall be payable within (7) days of demand upon the owner or occupier of any property, at the office of the Council during normal business hours.

7. The provisions of clauses 3, 4 and 5 of this By-law shall not apply to any land tenement or property supplied with water by the Council under a special agreement pursuant to section 215 of the *Water Act* 1958.
