#### 1. Purpose of the Scheme

The purpose of the Statewide Disabled Persons Parking Scheme is to provide people with significant ambulatory or intellectual disabilities with equality of opportunity to access facilities and services throughout the State.

The Scheme will be administered by individual municipal Councils in accordance with the guidelines in this Code, to ensure consistent administrative practices and eligibility criteria.

#### 2. Types of Permits

The following types of parking permits will be issued for use under the Disabled Persons Parking Scheme:

- (a) Code A for disabled passenger/driver,
- (b) Code B for passenger;
- (c) Code C for an organisation providing a transport service for people with disabilities; and
- (d) Code D for a temporary permit.

#### 3. Eligibility Criteria

(a) A person will be eligible for a disabled persons parking permit:

if a medical practitioner determines that he/she has a significant ambulatory disability such that he/she is incapable of walking:

- (i) unaided or unassisted; and
- (ii) up or down a slope of 1:14 (i.e. a wheelchair ramp); and
- (iii) up or down steps or gutters.

A significant permanent ambulatory disability is a disability that is not likely to improve in the person's lifespan (Code A or B).

A signficant long-term ambulatory disability is a disability that is not likely to improve within six months (Code D).

OR

—if a specialist medical practitioner or a clinical psychologist determines that he/she has a signficant intellectual disability such that he/she is an extreme danger to himself/herself and others in a public place without continous attendance by a caregiver (Code B).

(b) An organisation will be eligible for a disabled persons parking permit if it is recognised by a Council as providing a transport service for people with significant ambulatory or intellectual disabilities. An organisation providing transport for people with disabilities on an occasional basis (i.e. for a day or weekend trip) will be eligible for a trip specific permit (Code C).

#### 4. Disputed Eligibility

A Council must consult its Medical Officer of Health, the applicant's medical practitioner, specialist medical practitioner or clinical psychologist in the event of Council disputing an applicant's eligibility for a permit. Where an applicant is refused a permit, Council must give reasons for its decision in writing and reconsider the application if the applicant seeks a second opinion from another medical practitioner, specialist medical practitioner or clinical psychologist.

#### 5. Conditions of Use

The following conditions of use apply:

- (a) A permit is valid up to and including the expiry date, provided that the expiry date and permit number are legible;
- (b) The parking entitlements applicable to the permit apply anywhere in Victoria. Reciprocal arrangements between States which have been agreed to by the Australian Transport Advisory Council also apply;
- (c) The permit must be clearly displayed at the left side of the front windscreen, with the expiry date and permit number visible from the outside of the vehicle;
- (d) When requested by an authorised officer, a driver using the permit must-
  - -state his/her name and address;
  - -produce his/her driver's licence:
  - -show proof that he/she or a passenger in the vehicle is the permit holder, and
  - —move the vehicle from the reserved place if the officer deems that the permit is invalid or that there is insufficient proof that the driver or a passenger in the vehicle is the permit holder.
- (e) A driver using the permit must either be the permit holder or must be parking the vehicle for the convenience of the permit holder who needs to leave the vehicle;
- (f) The permit remains the property of the issuing Council, and must be returned within seven (7) days of notification of such return being required;
- (g) A person may only hold one permit;
- (h) An organisation may hold more than one permit but must justify in writing to the Council the number of permits required or any increase in the number of permits required. An organisation may also hold a trip specific permit;
- (i) Provided no other restrictions on parking are breached, a vehicle correctly displaying a valid disabled persons parking permit may be parked either—
  - —in a parking area or bay designated for use by people with disabilities, for the time and parking fee specified for that area or bay, if applicable; or
  - -for twice the specified time for any parking area or bay not designated for use by classes of people or classes or vehicles, upon payment of any initial parking fee, if applicable.

#### 6. Form of Permit

The form of the permit will be as shown below. It will display the permit number, expiry date and the name of the issuing municipality.

#### 7. Permit Application

Application forms will be provided by Councils. The forms will be similar to the sample attached as Appendix A.

If any permit is lost/stolen/damaged or otherwise rendered unusable, the applicant or the applicant's agent must submit a statutory declaration to the Council, giving details as to why the permit needs to be replaced and accompanied by supportive proof wherever possible. The Council shall issue a replacement permit on receipt of such declaration.

#### 8. Permit Renewal

Expiry dates have been established for administration purposes as follows:

- (a) 3 years from the date of issue for a Significant Permanent Ambulatory or Intellectual Disability;
- (b) 6 months from the date of issue for a Signficant Long-term Ambulatory Disability; or

(c) 12 months from the date of issue for an organisation providing a transport service for people with disabilities.

Councils may require a new application form for renewal of an existing permit, or may issue a new permit without an application on receipt of an expired permit.

#### 9. Permit Cancellation

A permit is automatically cancelled after the expiry date and may be cancelled at any time for wilful misuse or breach of the Conditions of Use. The issuing Council will notify the permit holder in writing of such cancellation and will require that the permit be returned within seven (7) days.

Title

 This Order may be cited as the Flora and Fauna Guarantee (Timber Harvesting) Order.

#### Power

- 2. This Order is made under section 48 (3) of the Flora and Fauna Guarantee Act 1988.
- Authority to take protected flora
  - 3. The Governor in Council authorises the taking, keeping and moving of protected flora, other than flora which is part or member of a taxon or community listed as threatened in Schedule 2 of the Flora and Fauna Guarantee Act 1988, in connection with timber harvesting operations as follows:
  - (a) A person who is—
    - (i) the holder of a lease, licence or other authority granted by or under an Act to harvest timber; or
    - (ii) authorised to act for the holder of such a lease, licence or authority; or
    - (iii) acting under the instruction of the holder of such a lease, licence or authority—

may take, keep and move protected flora if the taking, keeping and moving—

- (iv) is a result of and incidental to timber harvesting operations, not being operations for the construction or maintenance of a road or track, in accordance with the lease, licence or authority; and
- (v) is consistent with any Code under the Conservation, Forests and Lands Act 1987 for timber production, regulations under the Forests Act 1958 and any coupe plan or forest management plan of a kind referred
