**General**

Exec-U-Log is an automated electronic vehicle data capture system designed to record the vehicle driver, trip details and all associated running costs. Exec-U-Log processes the data into a number of reports, e.g. monthly chronological summary, detailed chronological trip and costs report, speed report, etc.

**Installation Cost**

The contractor—Automotive Electronic Specialists Pty Ltd (AES) will be responsible for performance and quality of the installation. Installation in the Melbourne Metropolitan Area will be at \$110 per vehicle. Installation in Country areas will be carried out in Rural Satellite towns such as—Ballarat, Bendigo, Morwell, etc. at a cost of \$150 per vehicle provided a minimum of ten (10) vehicles are available.

Installation Time—1.5 hours per installation including testing.

**Service and Support**

AES prior to installation will provide a liaison person to work with the appropriate officer of each Department to obtain details of drivers, trip purposes and other relevant information required to be entered into Exec-U-Log prior to installation.

The Department is required to send such details together with the vehicle registration and fleet number to the AES office in Camberwell for pre-loading and configuration prior to installation.

**User Training after Installation**

Directly after each batch of installations has taken place AES's liaison person will organise a group presentation to instruct drivers on the use of Exec-U-Log.

**"Hotline" Telephone Support**

AES has trained staff to assist with any operational queries, however, in the event the problem cannot be resolved AES will arrange for the liaison person to attend the problem on site. AES guarantee response time of less than 24 hours in the Metropolitan Area.

**Data Downloading Training**

After the equipment has been in a vehicle for a nominated period the unit will need to be removed to download the stored information. This is simply a matter of unclipping the unit from its bracket and connecting it to the allocated printer or computer.

AES will arrange a time with the appropriate officer to execute this task. They will also train the officer and supply a detailed manual on how to set up and test the unit to communicate with either a printer or computer. If a computer is involved software is available to perform downloads which can be printed or stored on either a hard or floppy disk.

Downloading software (including adapter plugs)—\$120 each—one copy per department is required.

**Training in Analysis of Data**

AES will give assistance to departmental officers to interpret and analyse data contained in various reports.

**Warranty**

12 months from date of installation against faulty workmanship or components.

The warranty is void if the unit has been opened or shows signs of rough treatment.

### Gazette Services

The *Victoria Government Gazette* (VGG) is published by VGPO for the State of Victoria and is produced in three editions.
