GUARANTEE/WARRANTY**

1 October 1991 to 30 September 1993

Century will repair or replace the battery free of charge within the specified period from date of purchase, if Century's standard tests prove the battery failed due to faulty workmanship and/or materials. This warranty is in addition to any condition or warranty imposed or implied by any laws in force in Australia. The original purchase docket should be presented when making a claim otherwise the sale code stamped on the battery will be used to determine the length of service.

**WARRANTY PERIOD**

A twelve (12) month warranty applies to all but Deep Cycle batteries. The guarantee period for Deep Cycle batteries is six (6) months.

The warranty does not apply if a battery fails because of damage caused by: incorrect connection of the battery to a vehicle, abuse, neglect or overcharging.

**DELIVERY**

FIS metropolitan area. Country areas FIS when delivered by a Century representative or FOB Spencer Street. All deliveries will be within 2—7 days of receipt of official order.

**BULK PURCHASES**

2.5% discount is offered on all quoted prices for single purchase of 20 units and over in any one product line. This offer does not extend to mixed orders.
