Wildlife Act 1975

NOTICE OF CLOSURE OF AREA TO
HUNTING

I give notice under section 86 of the *Wildlife Act 1975* that—

- (a) the taking, destroying or hunting of any kind or species of wildlife is prohibited in the area described in Schedule 1 during the period beginning on Saturday, 16 March 1991 and ending on Tuesday, 30 April 1991;
- (b) a person who takes, destroys or hunts any kind or species of wildlife in an area specified in Schedule 1 during the period specified in that Schedule is guilty of an offence and liable to a penalty not exceeding \$200.

Schedule 1

The area within 500 metres of the Wool Wool Rocks being the rocks near the shore of that part of Lake Corangamite which forms part of the boundary between the Shires of Colac and Hampden.
