FISHERIES (SCALLOP FISHING) NOTICE

No. 4/1991

Title

1. This Notice may be cited as the Fisheries (Scallop Fishing) Notice No. 4/1991.

Objective

2. The objective of this Notice is to protect and improve scallop fisheries and to fix a close season for commercial fishing for scallops in Port Phillip Bay.

Authorising Provision

3. This Notice is made under section 80 of the *Fisheries Act 1968*.

Close Season for Commercial Scallop Fishing in Port Phillip Bay

4. (1) A person must not dredge for scallops in Port Phillip Bay during the close season.

(2) During the close season a person must not in Port Phillip Bay take scallops for sale.

(3) The close season is the period commencing on 15 May 1991 and ending on 9 August 1991.

Penalty

5. Any person who contravenes this Notice is liable to a penalty of 20 penalty units.
