*Road Safety Act 1986*

1991 4 DAY AUSTRALIAN ENDURO

CHAMPIONSHIPS

Under section 68 (3) of the *Road Safety Act* 1986, I declare that sub-sections (1) and (2) of section 68 of the Act, the Road Safety (Traffic) Regulations 1988 and Parts 9 and 10 of the Road Safety (Vehicles) Regulations 1988 shall not apply with respect to the events known as the 1991 4 Day Australian Enduro Individual and Teams Championships and the Demon Ridge Enduro to be conducted by the Myrtleford Motorcycle and Speedway Club Inc. on sections of road within a 30 kilometre radius of Bright in the North Eastern Region of Victoria, between Friday, 17 May 1991 and Monday, 20 May 1991 inclusive between the hours of 7.00 a.m. and 5.00 p.m.
