NOTICE OF INTENTION TO MAKE
REGULATIONS

I, David White, the Minister administering the *Mineral Resources Development Act 1990*, give notice under the *Subordinate Legislation Act 1962* as follows:

The proposed—

Mineral Resources (Titles) Regulations 1991;
Mineral Resources (Mining Infringement) Regulations 1991;
Mineral Resources (Royalties) Regulations 1991;
Mineral Resources (Health and Safety) Regulations 1991; and
Mineral Resources (Certification of Mine Managers) Regulations 1991;

have been made the subject of a regulatory impact statement and a public comment period.

Submissions were received and have been considered as required by the *Subordinate Legislation Act 1962*.

I have decided to make the advertised regulations subject to a number of amendments. The advertised regulations were called "Mining" as a prefix to each title. The prefix has been amended to read "Mineral Resources". Other changes made are included to enhance the clarity and intent of the regulations.
