WATER ACT 1989

I, Steve Crabb, Minister for Conservation and Environment make the following Order:

CONSTITUTION OF THE MACEDON REGION WATER AUTHORITY ORDER 1991

- 1. This Order is called the Constitution of the Macedon Region Water Authority Order 1991.
- 2. This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.
- 3. This Order takes effect on the date on which it is published in the Government Gazette.
- 4. In this Order:

"Act" means the Water Act 1989;

"Former Authority" means-

- (a) the Macedon Water constituted by an Order in Council dated 29 May 1984; and
- (b) the Woodend Water Board constituted by an Order in Council dated 27 September 1983.
- 5. On and from the date on which this Order takes effect-
 - (a) there is constituted a new Authority;
 - (b) the corporate name of the new Authority is the Macedon Region Water Authority;
 - (c) the new Authority takes over the whole of the property, rights, liabilities, obligations, powers and functions under the Act of the

Former Authorities including the management and control of the existing water districts named below-

Mount Macedon Urban:

Mount Macedon Waterworks;

Woodend Urban;

Woodend Waterworks-

and the management and control of the existing sewerage district named below-

Woodend Sewerage;

- (d) and the new Authority takes over the staff of the Former Authorities.
- The interim membership of the new Authority is as follows:

Darryl Dalton;

Ched Flego; and

- 2 persons appointed by the Minister in writing.
 - 7. The Former Authorities are abolished.
- 8. (a) This is an Order referred to in section 98 (2) (a) of the Act.
- (b) Under section 100 (2) (a) of the Act the affected Authorities, the Macedon Water Board and the Woodend Water Board have applied to me for this Order to be made.
- (c) Under section 98 (2) (a) of the Act I have agreed the terms and conditions for the takeover made by this Order with the affected Authorities. Dated 20 November 1991
