DECLARATION OF FIRE DANGER PERIOD

In pursuance of the powers conferred by section 4 of the *Country Fire Authority Act 1958*, I, Leonard Raymond Foster, Chairman of the Country Fire Authority, after consultation with the Director-General of Conservation and Environment, hereby declare the following periods to be the Fire Danger Period in the municipalities or parts of municipalities specified, commencing on the dates shown and, unless varied by subsequent declaration, ending at 0100 hours on Friday, 1 May 1992.

HAWTHORN PLANNING SCHEME
Notice of Approval of Amendment
Amendment RL137

The Minister for Planning and Housing has approved Amendment RL137 to the Local Section of the Hawthorn Planning Scheme.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment affects land on the south-east corner of Tooronga Road and Toorak Road, Tooronga, and known as the Tooronga Village Shopping Centre, the former brickworks site and the Coles Myer Ltd head office. The amendment rezones that part of the land formerly reserved for proposed Public Open Space to a Comprehensive Development Zone No. 4 (Tooronga Activity Centre) and substitutes for the concept plan a new "Concept Plan and Building Envelope Plan".

The amendment allows new office buildings of 15 000 square metres floor area and associated carparking. It also allows the shopping centre to be redeveloped and enlarged to a total of 17 000 square metres of gross leasable floor area for shops and 2 700 square metres of floor area for other uses. Appropriate carparking spaces are required to be provided. Development plans, open space plans and traffic plans must be prepared to the requirements of the responsible authority. A section 173 agreement must also be entered into between the proponent and the responsible authority.

The amendment also reserves land on the north-west corner of Toorak Road and Tooronga Road for proposed road widening.

A copy of the amendment can be inspected, free of charge, during office hours, at the Department of Planning and Housing, Ground Floor, 477 Collins Street, Melbourne, and at the offices of the City of Hawthorn, 360 Burwood Road, Hawthorn.
