Advanced Education", "Consumer", "Co-operative", "Credit Union", "Executor", "Friendly Society", "Guarantee", "Institute", "Made in Australia", "Oxfam", "Savings", "Starr Bowkett", "Stock Exchange", "Trust", "Trustee", "University".

6. Names which, in the context in which they are proposed to be used, are capable of suggesting—

(a) connection with a member of the Royal Family when the connection suggested does not exist; or

REGULATORY IMPACT STATEMENTS  
Bunurong Marine Park Rules 1991

Three Regulatory Impact Statements (RIS) have been prepared in relation to the proposed Bunurong Marine Park Rules 1991. The Regulatory Impact Statements relate to the following aspects of the proposed rules:

- (1) Commercial fishing
  - (2) Recreational fishing/collecting
  - (3) Scientific studies/educational excursions.
- The principal objectives of the proposed rules are—

- (a) to secure the protection of the Bunurong area for conservation, scientific, education and recreation purposes; and
- (b) to protect and conserve the diversity and abundance of marine flora and fauna of the extensive Bunurong intertidal rock platform habitat; and
- (c) to protect and conserve the Bunurong subtidal area as an excellent example of flat, broken sedimentary reef habitat and associated biota, which interact with biota of the intertidal area.

In relation to commercial fishing, the RIS considered four alternatives and concluded that the proposed rules are the best means of achieving the stated objectives.

In relation to recreational fishing and collecting, the RIS considered eight alternatives and concluded that the proposed rules are the best means of achieving the stated objectives.

In relation to scientific studies and educational excursions within the Park, the RIS considered four alternatives and concluded that the proposed rules are the best means of achieving the stated objectives.

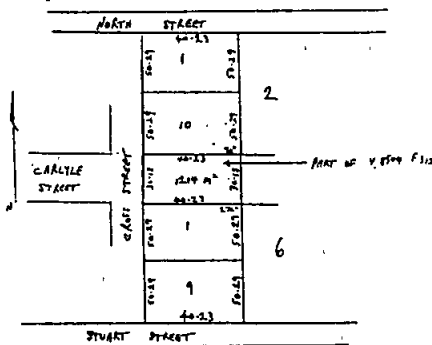

To detail the authorising provisions, set the operation date of the Local Laws, set the revocation date of the Local Laws and definitions to be used in the Local Laws.

To protect Council land, sewers, drains, water courses, trees and plants, vehicular crossings, kerbs and paths.

PART 5—USE OF COUNCIL LAND

To enable people to enjoy the use of public facilities without nuisance or undue disturbance from other people and to regulate the use of Middle Brighton Baths, Library Service, Public Reserves and Recreation Grounds, Rubbish Depot, Billilla, Town Hall and behaviour on any Council land or in any public place.

PART 6—POWERS OVER ROADS AND  
PUBLIC HIGHWAYS

Division 1—General

To regulate the use under clause 12 of Schedule 11 to the Act regarding the prohibition or

restriction of the use of a road or by pass by any vehicle over a certain size or weight.

**Division 9—Speed Limits for Vehicles**

To regulate the use of powers under clause 13 of Schedule 11 to the Act regarding speed limits for vehicles on any road or roads in the municipality.

**PART 8—STREET SELLING, COLLECTIONS AND DISTRIBUTIONS**

To regulate the selling of goods, other than from shops, and to regulate house to house collections and house to house distributions of materials.

**PART 9—PROTECTION OF THE AMENITY OF THE MUNICIPAL DISTRICT**

To protect the amenity of the municipal district.

**Division—General**

To regulate unsightly premises, camping on private property, caravans, trees and plants at intersections and overhanging trees.

**Division 2—Open-Air Burning and Incinerators**

To prohibit the lighting of fires in the open, on roads or within an incinerator without a permit.

**Division 3—Vermin and Noxious Weeds**

To provide that premises are kept free of rats and mice or other vermin and noxious weeds.

**Division 4—Fire Hazards**

To regulate the construction of fireplaces and chimneys, to prohibit the keeping of combustible material and require its removal.

**Division 5—Tennis Courts**

To regulate the provision of a drainage system, the hours of use, the provision of coaching and tennis ball machine on tennis courts in association with any dwelling.

**Division 6—Building Works**

To regulate the times at which building works may be carried out.

To regulate the keeping of domestic pets.

**PART 12—DEVELOPMENT CONTROL**

To adopt the requirements specified in Columns 1, 2, 3, 4 or 5 of Table 11.6 of the Victoria Building Regulations as the minimum requirements applying to an allotment and the siting of any Class I, II or X building thereon.

**PART 13—PERMITS**

To specify the conditions of and application format for all permits issued under the Local Law.

**PART 14—INFRINGEMENT NOTICES**

To implement the provision of infringement notices, identify persons able to issue infringement notices, state when and how infringement penalties are to be paid, ability to defend the prosecution in court and specifying the ability or Council to waive the notice.
