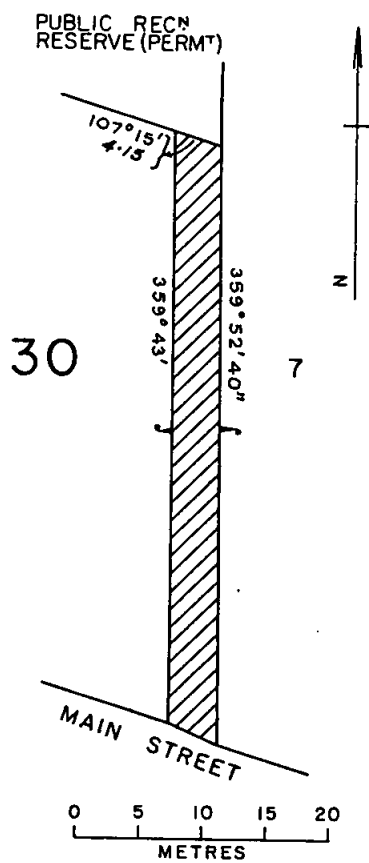

#### EXEMPTION

Application No. 11 of 1991

On 14 August 1991 the Equal Opportunity Board considered an application pursuant to section 40 (1) of the *Equal Opportunity Act 1984* ("the Act") by Eleanor Pugsley, Chairperson, and Libby Hotchin, Co-ordinator, for and on behalf of Courtney Youth Services Hostel to enable the Hostel to advertise for and employ women on the overnight shift at the Hostel.

Upon reading the material in support of this application, the Board is satisfied that it is appropriate to grant an exemption from sections 21 and 59 of the Act.

In granting the exemption the Board noted—

The hostel is managed by a community based management committee and is funded by Community Services, Victoria to provide accommodation for young women between the ages of fourteen and eighteen. A majority of residents are victims of sexual assault and as a result are distrustful of men.

Whilst men are employed at the hostel on day and evening shifts, when permanent staff are working, sleep-over shifts involve only one staff person and to involve men in having sole responsibility for young women during this overnight shift would prove unnecessarily stressful to residents.

The Board hereby grants an exemption to the Courtney Youth Services Hostel from the operation of sections 21 and 59 of the *Equal Opportunity Act 1984*, this exemption to remain in force until 14 August 1994.

- (h) permit any dog unless such dog is at all times controlled by a chain, cord or leash.

3. In the Reserve no person shall, unless authorised in writing by the Regional Manager, Department of Conservation and Environment, Mildura—

- (a) interfere with, mark, deface or damage, pick or injure any tree, shrub, flower, plant or any other vegetation;
- (b) light or cause to be lit any fire except in any properly constructed fireplace provided for that purpose;
- (c) camp;
- (d) drive any vehicle other than on a formed road or car park open to the public;
- (e) put or allow to remain any sheep, horses, cattle, pigs or other animals;
- (f) organise or take part in any public entertainment game or sport;

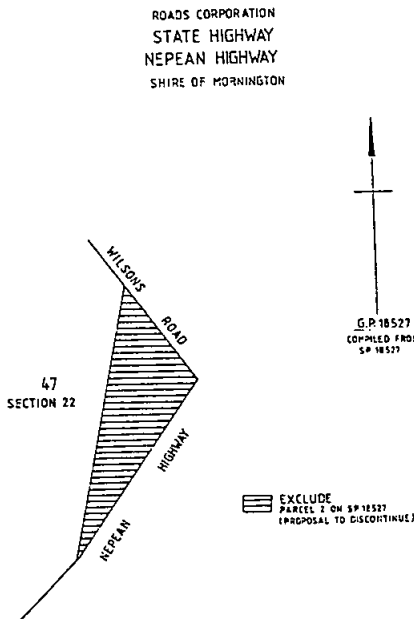
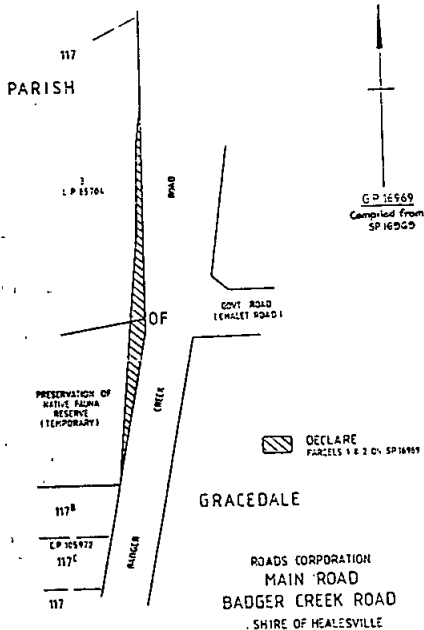
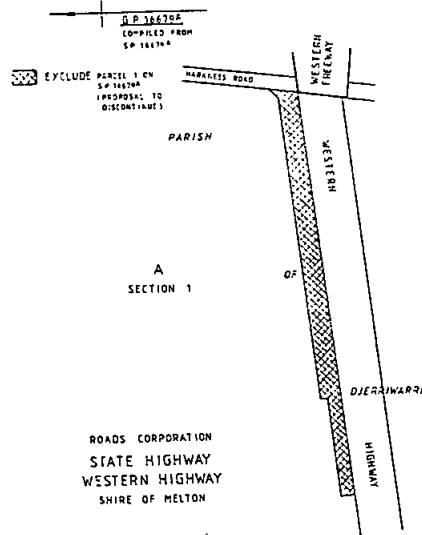

## RULES OF THE COUNCIL OF LEGAL EDUCATION (AMENDMENT NO. 1) 1991

Pursuant to the authority conferred on the Council of Legal Education by the *Legal Profession Practice Act 1958*, the Council makes the following Rules:

1. These Rules may be cited as the "Rules of the Council of Legal Education (Amendment No. 1) 1991".

2. In these Rules the Rules of the Council of Legal Education 1985 are called "the Principal Rules".

3. Amendment of Rule 3 (1) (b)

In Rule 3 (1) (b) of the Principal Rules, for "and the Australian National University" substitute "the Australian National University, Bond University, La Trobe University and Deakin University".

4. Amendment of Rules 12 (4) (b), 12 (5) and 15 (1)

In each of Rules 12 (4) (b), 12 (5) and 15 (1) of the Principal Rules, for "twelve" substitute "appropriate" and for "specified in" substitute "specified by".

5. Amendment of Rule 14 (a)

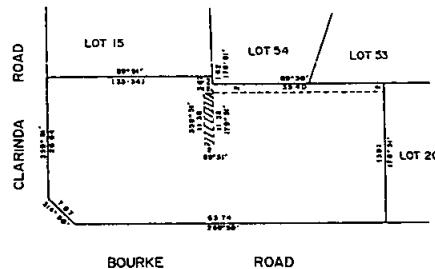

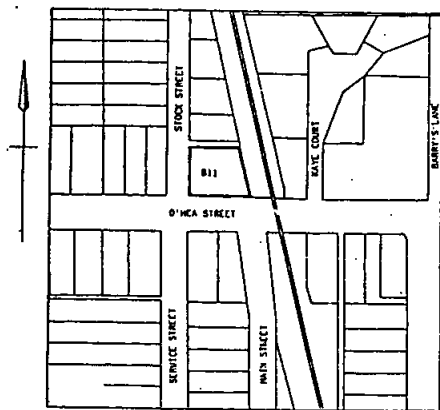

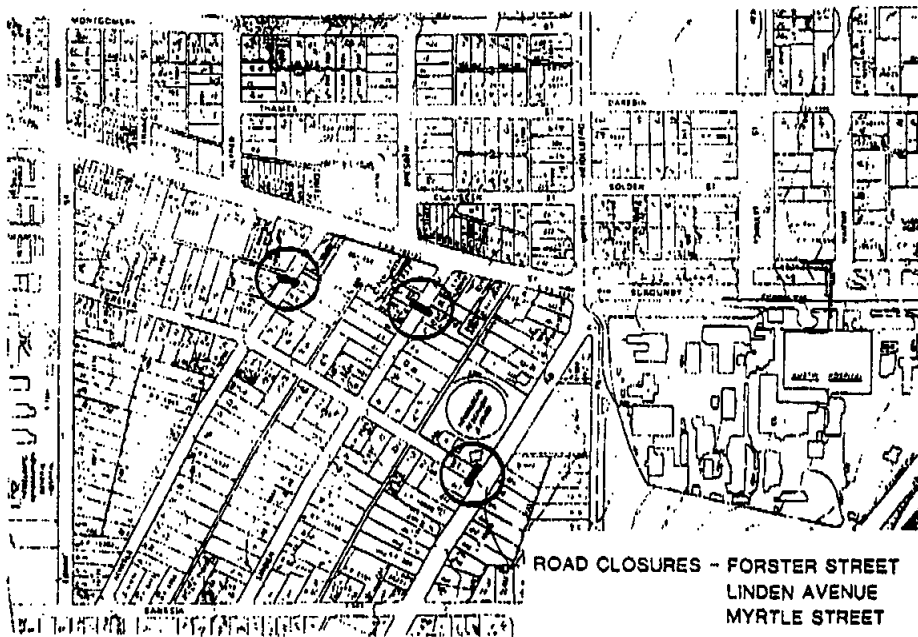
