



Regulations

KENNINGTON-STRATHDALE RESERVES Title

1. These Regulations may be cited as the Kennington-Strathdale Reserve Regulations 1991.

Objective

2. The objective of these Regulations is to provide for the care protection and management of certain reserves at Strathdale.

Authorising provisions

3. These Regulations are made under section 13 of the Crown Land (Reserves) Act 1978.

Commencement

4. These Regulations come into operation on the date they are published in the *Victoria Government Gazette*.

Definitions

5. In these Regulations-

"Act" means the Crown Land (Reserves) Act 1978.

"Appointed Officer" means any person appointed in writing by the Committee as an authorised officer for the purposes of these Regulations and (except for the purpose of receipt of any fees or the grant, variation or revocation of any permit) also includes any members of the Police Force and any person appointed or deemed to be appointed an authorised officer under section 83 of the Conservation Forests and Lands Act 1987.

"Camp" means:

- (a) to erect, occupy or use any tent or any temporary, make-shift or similar form of accommodation; or
- (b) to park occupy or use any caravan or other movable form of accommodation.

"Committee" means the committee of management appointed to manage the Reserve under section 14 of the Crown Land (Reserves) Act 1978.

"Firearm" includes any rifle, gun, pistol, air pistol or air gun or like thing using cartridges, catapult, bow and arrow, crossbow and any other implement designed to discharge missiles capable of injuring damaging or destroying any person animal or thing.

"Permit" includes any authority, approval, consent, permission, receipt, ticket or the like given granted or issued by the Committee under these Regulations.

"Vehicle" includes any motor car, motor cycle, bus, truck, bicycle, cart, horse-drawn vehicle, caravan, trailer or water craft. "Litter" includes any bottle, carton, package, paper, glass, food, offal, animal carcass, vegetable matter or refuse or rubbish.

"Reserve" means the land referred to in the schedule.

Schedule

1. Strathdale Park Recreation Reserve (Rs 6909)

Crown land comprising 27.2 hectares being Crown Allotments 81F, 81G, 81H and 81J, Parish of Sandhurst, County of Bendigo, which was temporarily reserved for Public Recreation by Order in Council of 29 April 1952 (refer Government Gazette of 7 May 1952), as shown on plan S/25.2.91 on Department of Conservation and Environment file 06/7209.

2. Kennington (Grassy Flat) Reservoir Recreation Reserve (Rs 6170)

Crown land comprising thirteen hectares being Crown Allotment 81D, no section, Parish of Sandhurst, County of Bendigo, which was temporarily reserved for Public Recreation by Order in Council of 18 December 1979 (refer Government Gazette of 4 January 1980, page 45), as shown on plan S/15.12.1978 on Department of Conservation and Environment file 06/9692.

3. Kennington Public Gardens Reserve (Rs 782)

Crown land comprising 1-1 hectares being Crown Allotment 81B, no section, Parish of Sandhurst, County of Bendigo, which was temporarily reserved as a site for Public Gardens by Order in Council dated 24 September 1912 (refer Government Gazette of 2 October 1912), as shown on plan \$/6.5.91 on Department of Conservation and Environment file 06/10159.

4. Shire of Strathfieldsaye Public Purposes (Municipal Offices and Civic Centre) Reserve (Rs 1755)

Crown land comprising 0-9 hectares being Crown Allotment 81A, no section, Parish of Sandhurst, County of Bendigo, which was temporarily reserved as a site for Public Purposes (Municipal Offices and Civic Centre) by Order in Council of 25 May 1971 (refer Government Gazette of 2 June 1971, page 1873), as shown on plan S/23.4.71 on Department of Conservation and Environment file 06/6854.

PART I—GENERAL

Powers Functions and Duties of the Committee

- 6. (1) Except as provided in these Regulations the reserve is open to the public free of charge.
- (2) The Committee may determine, in either general or specific terms, the times and days on which the whole or any part of the reserve will not be available for use by the public.

- (3) The Committee may enclose or set aside for a particular activity the whole or any part of the reserve and may include in that determination, conditions or restrictions relating to the use by the public of that area.
- (4) The Committee may determine the conditions of entry or use of any conveniences, facilities or amenities of any description in any part of the reserve.

Granting of Permits

- 7. (1) Any permit may be granted for such period and subject to such terms, conditions and fees, consistent with these Regulations as the Committee may from time to time determine either generally or in the particular case.
 - (2) No permit shall be transferable.
- (3) Any permit may be revoked or withdrawn at the discretion of the Committee.
- (4) The holder of any permit shall observe and comply with all conditions thereof.
- (5) Any person purporting to hold any permit shall produce the same on demand by any appointed officer and unless such permit is thereupon produced that person shall not be entitled to claim the benefit of any such permit.

Directions to Leave

- 8. (1) Any appointed officer may direct any person who in his opinion offends against these Regulations forthwith to leave the reserve or any place therein.
- (2) Every person who fails to comply forthwith any such direction shall be guilty of an offence.

Giving of Name

9. If, in the opinion of an appointed officer, any person has contravened or failed to comply with any provision of these Regulations then such officer may demand and receive the name and address of such person. Any person who refuses when asked by such officer to furnish their name and address or who furnishes an incorrect name and address shall be deemed to have committed an offence against these Regulations.

Obstruction of Officers

10. No person shall obstruct, hinder or interfere with any appointed officer or any employee of the Committee in the execution of their duties in the reserve.

PART II—USE AND PROTECTION OF THE RESERVE

Behaviour

- 11. (1) Within the reserve a person must
- (a) behave in a noisy or disorderly manner or create or take part in any disturbance or commit any act of indecency or offend against decency as regards dress, language or conduct;

- (b) commit or create or knowingly permit or allow to continue any public or private nuisance, or any annoyance to the public or any persons lawfully in the reserve;
- (c) roll or throw any stone or other substance or missile within the reserve which is likely to damage property or endanger or annoy other persons lawfully using the reserve;
- (d) expectorate, urinate or defecate except in a place set apart for that purpose.
- (2) Any axe, shovel, knife, implement or substance found being used in contravention of the Regulations may be seized by an authorised officer and retained by such officer until the completion of proceedings in a court of law.
- (3) If equipment is seized pursuant to subregulation (2) and proceedings are not instigated within twenty-eight days the said equipment shall be returned to the owner.
- (4) If equipment is to be returned to the owner pursuant to sub-regulation (3) the Committee shall notify the owner in writing who shall be responsible for its collection.

Shooting and Trapping

- 12. (1) Within the reserve a person must not, except in accordance with a written permit—
 - (a) shoot, trap, maim, injure, kill or destroy any bird or animal;
 - (b) have in their possession or carry or use any firearm, poison, trap or snare.

Firearms

- 13. (1) Any person carrying or using any firearm, poison, trap or snare in the reserve without a permit shall surrender the same on demand to any appointed officer who shall issue a receipt therefor.
- (2) The person apparently entitled to any such article may collect it from the office of the Committee after completion of investigations and legal proceedings (if any) by the Committee in relation to any offence alleged against the person who surrendered the same.
- (3) Where proceedings are not initiated within twenty-eight days of seizure in relation to any firearm seized pursuant to sub-regulation (1), the Committee shall notify the owner in writing and the owner shall be responsible for the collection of the said firearm.

Damage

- 14. Within the reserve a person must not, except in accordance with a written permit—
 - (a) remove, cut, damage, displace, deface, or interfere with any rock, timber, tree, shrub, plant, wildflower or other vegetation or any sign, noticeboard, seat, table, gate, post, fence, bridge, building, structure or any other thing of a like nature;

(b) dig up or remove from or bring into the reserve any gravel, stone, shell-grit, sand, soil or loam.

Games

- 15. Within the reserve a person must not-
- (a) play any game in which a hard ball is used except in an area set aside for the purpose;
- (b) engage in any game, activity or sport likely to cause interference, disturbance, inconvenience or danger to others using the reserve.

Camping

16. A person must not camp in any part of the reserve without the written permission of the Committee being first obtained and only under such conditions as the Committee may determine.

Refuse and Litter

- 17. (1) A person must not-
- (a) within the reserve deposit or cause to be deposited, except in a receptacle provided for that purpose, any litter;
- (b) bring into the reserve and deposit or allow to remain any domestic or household waste, car body, building material or other waste: or
- (c) intentionally break any glass bottle or other container within the reserve.
- (2) Any person who breaks any glass in the reserve shall gather up the pieces and remove them or place them in a receptacle provided for litter.

Business and Advertising

- 18. Within the reserve a person must not, except in accordance with a written permit—
 - (a) sell or offer for sale any article whatsoever:
 - (b) give out, distribute, erect, leave set up or display any handbill, placard, notice, pamphlet, book, paper, advertising matter or any like thing;
 - (c) occupy, use or enter any building, booth, shed, stand or enclosure unless the same is set aside for public use;
 - (d) erect or place therein any building, booth, shed or other structure;
 - (e) solicit or collect money or orders for goods or services;
 - (f) take part in or advertise any entertainment for gain;
 - (g) preach, declaim, harangue or deliver any address of any kind or use any amplifier, public address system, loud hailer or similar device;
 - (h) offer for hire any article, device or thing;
 - (i) take photographs for gain or commercial purposes;

- (j) ply any vehicle for hire or carry any passengers for fee or reward;
- (k) conduct any school or provide any form of instruction for gain;
- (1) advertise for sale or trade or hire any article, device, service or thing;
- (m) disturb, interfere with or destroy any animal or bird or its lair or nest;
- (n) operate any portable or stationary generator, air-compressor or chainsaw.

Dogs

- 19. (1) A person must not suffer or permit any dog belonging to them or in their charge—
 - (a) to be brought into the reserve unless such dog is and continues to be at all times under proper control on a chain, cord or leash and unless such dog be effectively restrained from causing annoyance to any person and from damaging or interfering in any way with any property in the reserve:
 - (b) to be brought into or to enter or remain in any portion of the reserve prohibited to the entry of dogs and indicated by notice.
- (2) Nothing in this Regulation prohibits a blind person having in the reserve a dog that is used by that person as a guide dog.

Horses

20. No person shall ride, drive or lead any horse upon the reserve.

Animals Generally

21. Except as aforesaid, no person shall cause or suffer or knowingly permit any animal belonging to them or in their charge to be brought into or remain in the reserve without a permit.

Enclosures

22. A person must not, without the consent in writing of the Committee, enter any area in the reserve which is enclosed for the plantation of young trees, shrubs or grass plots or for the rehabilitation or preservation of native flora or any other purpose.

Fires

23. A person must not without a permit, light a fire in the reserve except in a portable barbecue or in a fireplace provided by the Committee. Any person who lights a fire in the reserve shall take all reasonable and proper precautions to ensure that the fire does not escape from control or damage anything growing or being on the reserve.

Roadways

24. A person must not, unless authorised by the Committee, drive, ride, push, pull, place or leave any vehicle in or on the reserve except in or upon such roadways or areas as are set aside for the purpose and no person shall allow any vehicle to remain stationary in any position

where it may cause undue or unreasonable obstruction to the lawful passage of others.

Parking

- 25. (1) A person must not park any vehicle within the reserve except—
 - (a) in an area set apart for the purpose;
 - (b) as and where directed or authorised by the Committee or an appointed officer; and
 - (c) upon payment of such fees (if any) as may be prescribed from time to time by the Committee.
- 2. An appointed officer may remove or cause to be removed any parked, stranded or brokendown vehicle from any roadway or area within the reserve provided that the removal of any vehicle—
 - (a) shall be at the sole risk of the owner of the vehicle who shall be deemed to have accepted such risk as a condition of entry to the reserve; and
 - (b) may be effected in such a manner as the appointed officer deems fit.

Abandoned Vehicles

26. Any vehicle left unattended within the reserve for a continuous period exceeding forty-eight hours may be removed by the Committee at the risk and expense of the owner.

Use of Facilities

- 27. A person must not-
- (a) use any kitchen, laundry, change-room, shower, toilet, or other convenience or any part thereof in the reserve except for its proper purpose and upon payment of such fees (if any) as may be prescribed in any permit; and
- (b) enter or use or permit any child under their care or control to enter or use any place, room, convenience, or structure set apart for the use of the opposite sex, provided that this Regulation shall not apply to a child under the age of six years when accompanied by an adult of the opposite sex.

Directions by Sign'

- 28. (1) The Committee may, by clear notices or signs established in such prominent position or positions as the case may require, prohibit or regulate any act matter or thing within the reserve or any part thereof, as specified in these Regulations.
- (2) No person shall erect or remove or deface any such notice or sign except with the authority of the Committee.
- (3) No person shall disobey the directions indicated in any such notice or sign.

- 29. Within the reserve a person must not-
- (a) by driving any vehicle deliberately damage any vegetation or unduly interfere with any sand, stone, gravel, rock, clay or earth;
- (b) drive any vehicle in a manner dangerous to the public;
- (c) drive any vehicle so as to cause noise which is unreasonable in the circumstances; and
- (d) drive any vehicle at a speed greater than that indicated by any sign or notice.

Sports and Competitions

- 30. Within the reserve a person must not-
- (a) enter cross, be on or trespass on any playing ground area or any area set aside for public safety or any enclosure, course, building room, structure or any part thereof whilst any sport, game, competition, race, entertainment or amusement is being played, conducted, or carried on, or at any time between the commencement and conclusion of any event without the consent of the Committee;
- (b) interfere with or interrupt any game, sport, competition, entertainment, amusement or practice in the reserve;
- (c) obtain or attempt to obtain admission to any part of the reserve when not entitled to admission under these Regulations;
- (d) play or practise the sport of golf;
- (e) play or practise any other sport, which in the opinion of the Committee constitutes a danger or nuisance to the owners or occupiers of nearby properties;
- (f) use model aeroplanes, either radiocontrolled or hand-held.

Penalties

31. Any person who contravenes or fails to comply with these Regulations is guilty of an offence and liable for the penalties prescribed in section 13 of the Crown Land (Reserves) Act 1978.

Revocation of Existing Regulations

32. The Kennington Public Gardens Regulations made on 22 January 1919 are hereby revoked.

LAKE MARMA RESERVE AND RABL PARK

Fitle

1. These Regulations may be cited as the Lake Marma Reserve and Rabl Park (Extension) Regulations 1991.

Principal Regulations

2. In these Regulations the regulations made on 11 July 1991 and published in the *Victoria Government Gazette* on 17 July 1991 for or in respect to Lake Marma Reserve and Rabl Park are called the Principal Regulations.

Authorising Provisions

3. These Regulations are made under section 13 of the Crown Land (Reserves) Act 1978.

Commencement

4. These Regulations come into operation on the date they are published in the *Victoria Government Gazette*.

Extension of Principal Regulations

5. The Principal Regulations are extended to the remaining lands in the Township of Murtoa temporarily reserved as a site for Water Supply Purposes by Orders in Council of 7 June 1886 and 18 June 1900—(Rs 1646).


