#### **GOVERNMENT NOTICES**

#### ROAD SAFETY (VEHICLES) REGULATIONS 1988

General Mass and Dimension Permit-Articulated Vehicles, Rigid Vehicles, Rigid Vehicle and Trailer Combinations and Mobile Cranes

Regulation 724 of the Road Safety (Vehicles) Regulations 1988 authorises the Roads Corporation, by notice in the Government Gazette, to allow vehicles which exceed mass or dimension limits prescribed in the Regulations to be used on highways.

Regulation 807 of the Road Safety (Vehicles) 1988 (amongst other things) prohibits the use of a vehicle on a highway if any part of the load carried on the vehicle projects more than 1-2 metres beyond the rear of the vehicle.

Regulation 819 of the Road Safety (Vehicles) Regulations 1988 authorises the Roads Corporation to approve the use on a highway of a motor vehicle towing more than one other vehicle.

In accordance with those Regulations, I, David O'Sullivan, delegate of the Roads Corporation, allow motor vehicles specified in Part 1 of the following schedule which are within the mass and dimension limits specified in Part 2 to be used on highways (other than the Unauthorised Roads) specified in Part 3 on condition that they are operated in accordance with Part 4.

The whole of the notice under those Regulations published in the Government Gazette No. S61 dated 7 December 1990 is revoked.

## THE SCHEDULE PART 1—SPECIFIED VEHICLES

## 1.1 Specified vehicles

This General Mass and Dimension Permit applies to the following vehicles:

Rigid mobile crane

Rigid vehicle or rigid vehicle and trailer

Articulated vehicle

Extendible articulated vehicle

Articulated low loader.

#### 1.2 Approved multiple articulations

Permission is hereby given pursuant to Regulation 819 of the Road Safety (Vehicles) Regulations 1988 for operation of an articulated low loader consisting of a prime mover towing a dolly and a semi-trailer.

#### 1.3 Definitions

In this Schedule-

"articulated low loader" means a vehicle consisting of a prime mover and a gooseneck semitrailer with the loading area of the semi-trailer a maximum of I, metre off the ground. To operate above statutory mass limits the prime mover must be tandem drive and together with the gooseneck semi-trailer must be designed and manufactured and plated to operate at the required mass limits.

"articulated vehicle" means a vehicle consisting of a prime mover and a semi-trailer.

"dolly" means a type of semi-trailer designed to load share but not to directly carry any cargo and with one or more axles, equipped with a king pin, a fifth wheel and other parts necessary for attaching it to the rear end of a prime mover and the front portion of a second gooseneck semi-trailer.

"extendible articulated vehicle" means a vehicle combination consisting of a prime mover and an extendible semi-trailer combination carrying a long indivisible item resulting in the overall length of the vehicle and load exceeding 17-5 metres but not exceeding 2-5 metres wide or 4-3 metres in overall height.

"gross vehicle mass" means the maximum permissible mass as defined in Regulation 205 (3) of the Road Safety (Procedures) Regulations 1988.

"holiday period" means three or more consecutive days which includes a gazetted Statewide school holiday or public holiday and a Saturday or Sunday at the start or end or within

"indivisible item" means an item which cannot reasonably be divided into two or more items for road transport, and cannot be carried on an appropriate vehicle within the mass and dimension limits prescribed in the Road Safety (Vehicles) Regulations 1988. Indivisible items shall not be loaded side by side to a width in excess of 2.5 metres; or one above the other to an overall height in excess of 4-3 metres; or one behind the other to an overall length in excess of 11 metres for a rigid vehicle, or 17-5 metres for an articulated vehicle or a rigid vehicle and trailer; or to a mass in excess of statutory mass limits. Where the indivisible item can reasonably be loaded in more than one way, it shall be loaded in the way which minimises width.

"metropolitan areas" means those parts of Melbourne and Geelong as defined in Appendix 1. "overhang line" means:

(a) for a single axle: the centre line of the rear axle;

(b) for a tandem axle group: where both rear axles are fitted with an equal number of tyres, a line midway between and parallel to the centre lines of those axles; where one rear axle is fitted with more tyres than the other axle, a line parallel to the centre lines of those axles and located one third of the total distance between the two axles and nearer to the axle with the most tyres;

of the great residence of the control of the contro a line midway between and parallel to the outside rear axles of that axle group.

"pilot vehicle" means a motor vehicle up to 4-5 tonnes Gross Vehicle Mass or, if it exceeds 4-5 tonnes, means a motor vehicle with a body width not exceeding 2-0 metres and overall length not exceeding 7-0 metres, carrying no visible load, and complying with the specified conditions of Part 4.7 and 4.8 of this Gazette notice.

"prime mover" means a motor vehicle that is constructed, designed or adapted for connecting to a semi-trailer.

"public holiday" means Australia Day, Labour Day, Good Friday, Easter Monday, Anzac Day and Queen's Birthday.

"rear overhang", in respect of a vehicle, means the distance between the rearmost point of the vehicle (and any load) and the overhang line.

"restricted road" means a high traffic volume road listed in Appendix 2 to which special travel 

restrictions specified in Part 4 apply.

"rigid mobile crane" means a right-hand drive non-load-carrying self-propelled rigid vehicle designed for lifting heavy objects by way of a boom with lifting gear.

"rigid vehicle" means a vehicle with its own motive power, other than a rigid mobile crane or bus, that can tow a trailer.

"RoRVL Option A'or Option C axle mass limits" means limits specified in the 'Review of Road Vehicle Limits' study for vehicles using Australian Roads published by the National Association of Australian State Road Authorities in November 1985.

"semi-trailer" means a vehicle without its own motive power which is capable of being drawn by a prime mover in such a way that it is attached to and pivoted on the prime mover by imposition on it on or in front of the rear axle of the prime mover so that the semi-trailer is free to turn relative to the prime mover when the prime mover is rounding a curve and so that part of the mass of the semi-trailer and any load carried on it is borne by the prime

"standards for registration" means the standards published in the Government Gazette No. S15 dated 1 March 1988 under section 10 (1) of the Road Safety Act 1986.

"statutory mass limits" and "statutory dimension limits" means limits specified in Part 7 of the Road Safety (Vehicles) Regulations 1988 and the standards for registration.

"street lighting" means areas where there is artificial lighting by luminaires which are at a maximum distance of 100 metres apart:

"truler" means a vehicle without its own motive power which is capable of being drawn by a

#### PART 2—MASS AND DIMENSION LIMITS

- 2.1 Scope
- 2.1.1 This permit only covers vehicles carrying indivisible items and rigid mobile cranes.
- 2.1.2 Where dimension and mass limits are not specified, vehicles must comply with the statutory mass limits and statutory dimension limits specified in the standards for registration and the Road Safety (Vehicles) Regulations 1988.
- 2.2 Dimension limits
- 2.2.1 Dimension limits allowed under this permit are set out in Tables 1 and 2.
- 2.2.2 Unloaded extendible articulated vehicles and the jib or boom of mobile cranes shall be retracted to the minimum possible length during travel.

#### 2.3 Mass limits

- 2.3.1 Statutory mass limits shall apply except:
  - (a) where a Mass Limit Increase Permit has been issued to allow up to RoRVL Option A or Option C axle mass limits;
  - (b) for articulated low loaders covered by the provisions of section 2.3.2 of this Gazette notice; and 😘
  - (c) for rigid mobile cranes covered by the provisions of section 2.3.2 of this Gazette notice.
- 2.3.2 Subject to the route restrictions specified in Part 3, and to any mass limit specified by a manufacturer for the vehicle or its component parts, the following mass limits shall apply to articulated low loaders and to rigid mobile cranes:

In (ii), if the minimum distance is less, the gross mass is to be reduced by 1 tonne for every 0.3 metres or part thereof less than the minimum distance.

#### PART 3—SPECIFIED ROADS

#### 3.1 Authorised roads

3.1.1 Subject to the exclusions in section 3.2, this permit authorises travel on Freeways, State Highways and Main Roads as declared in the *Transport Act* 1983 and on other highways that are reserved as Main and Secondary roads as defined by the Ministry of Planning and Environment in its Planning Schemes, and on the following Tourists' and Forest Roads declared in accordance with the *Transport Act* 1983:

the Bruthen-Buchan Road between Bruthen and the Red Knob Road; and the Red Knob Road.

3.1.2 Travel is not permitted on Unauthorised Roads as specified in section 3.2. Travel on other roads is only authorised by this permit on the most direct and practicable route between the point of pickup or delivery, and the nearest authorised road.

## 3.2 Unauthorised roads

- 3.2.1 This permit does not authorise travel on:
  - (a) Tourists' and Forest Roads declared in accordance with the Transport Act 1983 except as specified in 3.1.1;
  - (b) roads or bridges subject to a mass or dimension limit as shown on a notice posted on the approaches to the road or bridge or as listed in Appendix 3.1; and
  - (c) roads in the mountainous and excluded areas described in Appendix 3.2.

### PART 4—SPECIFIED CONDITIONS

#### 4.1 Travel time restrictions

- 4.1.1 For all vehicles, travel is only permitted when atmospheric conditions allow visibility beyond 500 metres.
- 4.1.2 For rigid mobile cranes, day travel (between sunrise and sunset) is permitted and night travel (between sunset and sunrise) is only permitted in accordance with the special conditions in sections 4.2 and 4.3.
- 4.1.3 For vehicles (other than rigid mobile cranes), travel is not permitted between 23 December and 3 January both days inclusive, on the restricted roads listed in Appendix 2, and on the following roads:

Hume Highway and Freeway between Goulburn Valley Highway and Wodonga;

Calder Highway between Bendigo and Yelta;

Goulburn Valley Highway between Yea and NSW border, and between Cathkin and Eildon;

Princes Highway between Warrnambool and SA border;

Western Highway between Ballarat and SA border.

#### On other days:

Saturday

(a) In Metropolitan areas:

Night travel (between sunset and 2.00 a.m.) is not permitted.

Night travel (between 2.00 a.m. and sunrise) is only permitted in accordance with the special conditions in section 4.2.

Day travel (between sunrise and sunset) is permitted subject to the restrictions specified in Table 3.

\* NOTE: In the Shire of Mornington and the Shire of Flinders these restrictions apply only between November and May.

(b) Outside Metropolitan areas:

Where the width of a load exceeds 2-5 metres or the length of the vehicle (and load) exceeds 19 metres:

Night travel (between sunset and sunrise) is not permitted.

Day travel (between sunrise and sunset) is permitted with travel time restrictions only on the restricted roads listed in Appendix 2.

On these restricted roads, travel is not permitted between 4.00 p.m. and sunset on Sundays, public holidays, and any day before the start of or at the end of a holiday period.

#### 4.2 Specific conditions for night travel

- 4.2.1 Pilot Vehicle and Street Lighting: For vehicles other than rigid mobile cranes exceeding 3-0 metres wide and/or 19 metres long, travel between 2.00 a.m. and sunrise in the Metropolitan areas is only allowed in areas with street lighting and with a pilot vehicle.
- 4.2.2 Side Facing Lamps: For rigid mobile cranes, travel between sunset and sunrise is allowed if an amber side facing lamp is fixed on both sides and towards the foremost extremity of a boom or jib, when the boom or jib projects more than 1.2 metres forward of the vehicle. These additional lamps must be shielded from the driver's view.
- 4.2.3 For any vehicle covered under this General Mass and Dimension Permit, travel during the permitted night travel times is only allowed under the following special conditions:
  - (a) Rotating Lights/Hazard Marker. At least one but no more than two amber rotating lights must be mounted as close as practicable to the highest point(s) on the cabin of the vehicle and one light must be mounted at the rear of the vehicle. While travelling, the lights must be clearly visible from a distance of 500 metres to both approaching and following vehicles. Any projection of the load beyond the body of the vehicle must have a reflective yellow or orange hazard marker at least 450 × 450 mm attached to the front and rear extremities of the load, or an amber rotating light so as to make the load clearly visible; and
  - (b) Side Marker Lamps: Side marker lamps showing amber to the front and red to the rear must be displayed at not more than 2 metre intervals around the perimeter of any load projecting from the vehicle.

#### 4.3 Operating conditions for travel on the Westgate Bridge

4.3.1 Mobile cranes and articulated low loaders operating under the mass limits specified in section 2.3 of this Gazette are only allowed to travel over the Westgate Bridge in the extreme right-hand lane of either carriageway. One pilot vehicle is required, at a distance not exceeding 50 metres from the rear of the overdimensional vehicle, if the overdimensional vehicle is not capable of maintaining a speed of 65 km/h or more on the upgrade of the bridge.

## 4.4 Hazard warning devices for the vehicle

- 4.4.1 Hazard Stripes: For rigid mobile cranes only, black on white diagonal hazard stripes with a minimum area of 0-15 square metres must be fixed on the left and right-hand sides of the boom head and hook block of the boom or jib.
- 4.4.2 Headlights: For day travel (between sunrise and sunset), the headlights must be lit on low
- 4.4.3 Flags/Hazard Boards: Where the overall width exceeds 2-5 metres, bright orange or yellow fluorescent flags at least 450mm square must be attached to or adjacent to the extremities of the load or the rigid mobile crane. Any projecting load, which is less than 1 metre in height, must also have a bright orange or yellow hazard board of 1 square metre attached to the front and rear extremities of the load.
- 4.4.4 Warning Signs: Where overall width exceeds 2.5 metres and/or overall length exceeds 18.0 metres, warning signs must be fixed upright to the front and rear of the vehicle so as to be clearly visible to approaching and following traffic respectively.

.The warning sign must be constructed of rigid material and have black lettering on retro reflective yellow background complying with Australian Standards AS1906—1976 Class 1 or Class 2. For day travel only, the sign may be constructed of flexible material and have black lettering on fluorescent yellow background. The legends for the warning sign must be maintained in a clear and legible condition and must comply with Australian Standard 1744 series D and E. The minimum sizes of signs and letters are:

When operating within statutory limits, warning signs must not be displayed.

#### 4.5 Operating conditions for the vehicle

- 4.5.1 Route: It is the responsibility of both the driver and the owner of the vehicle to ensure that the proposed route is suitable (having regard to the width of the road, the type and dimensions of the vehicle, the anticipated time to traverse the route and the amount of traffic expected to be on the route at that time) and minimises inconvenience to other road users by avoiding peak traffic periods. Where practicable, Overdimensional Routes should be used between the point of pickup or delivery.
- 4.5.2 Overhead Clearance: It is the responsibility of both the owner and the driver of the vehicle to ensure that the clearance to overhead structures, cables, wires and trees is sufficient to ensure
- 4.5.3 Distance between Vehicles: A motor vehicle operating under this notice must leave at least 200 metres headway to any other motor vehicle exceeding 18.0 metres in length and/or 2.5 metres in width.
- 4.5.4 Allowing Vehicles to Overtake: If the traffic is banking up behind the overdimensional vehicle, the driver must where it is safe to do so, move the motor vehicle to the side, and if necessary stop to allow following vehicles to overtake.
- 4.5.5 Reducing Dimensions: It is the responsibility of the owner of the vehicle to ensure that the most appropriate vehicle is used so that overall dimensions are kept to the minimum.
- Authorisation bodies
- 4.6.1 Melbourne City: For travel in that area of the City of Melbourne bounded by the eastern side of Spring Street, the northern side of Latrobe Street, the western side of King Street and the southern side of Flinders Street, permission of the Melbourne City Council must be obtained.
- Hazard warning devices for pilot vehicles
- 4.7.1 Warning Signs/Rotating Lights: A pilot vehicle must carry a warning sign mounted upright, and display one or two amber rotating lights mounted as close as practicable to the highest point(s) on the pilot vehicle so that they are clearly visible from a distance of 500 metres to both approaching and following vehicles.

The warning signs of pilot vehicles must be constructed of rigid material and have black lettering on retro reflective yellow background complying with Australian Standards AS1906-1976 Class 1 or Class 2. The legends for the warning signs must be black and must comply with Australian Standard 1744 series D and E with the minimum size of signs and letters as follows:

When not acting as a pilot vehicle, warning signs must not be displayed.

- 4.7.2 Headlights: While escorting, the headlights of a pilot vehicle must be on low beam at all times.
- 4.7.3 Radio Communication: Radio communication facilities between the drivers of the pilot vehicle and the overdimensional vehicle must be available at all times.
- Operating conditions for pilot vehicles
- 4.8.1 Loads: Pilot vehicles must not carry any visible loads.
- 4.8.2 Towing: Pilot vehicles must not be used to tow other vehicles or trailers.
- 4.8.3 Escorting Distance: A single pilot vehicle must travel at a distance not exceeding 400 metres to give adequate warning in front of the overdimensional vehicle, except on dual carriageways where the pilot vehicle must travel at the rear of the overdimensional vehicle at a distance not exceeding 50 metres.

On 17 October 1991 the Minister for Planning and Housing refused the above amendment.

The amendment proposed to introduce a site specific clause into the scheme to allow for an existing business on the Great Ocean Road to erect an internally illuminated advertising sign no greater than two metres square in area.


