Vegetation and Vine Diseases Act 1958
PROCLAMATION

Prohibition on Removal of Potato Tubers and Plants of Tomato and Eggplant from a Proclaimed Area for the Purpose of Preventing the Spread of Potato Cyst Nematode

I, J. Davis McCaughey, Governor of Victoria, acting with the advice of the Executive Council and under section 5 of the *Vegetation and Vine Diseases Act 1958* prohibit the removal from the portion of Victoria specified in the Schedule to this Proclamation into any other portion of Victoria any potato tubers and any plants of tomato and eggplant for the purpose of preventing the spread of the pernicious parasites *Globodera Rostochiensis* (Woll.) and *Globodera Pallida* (Stone).

SCHEDULE

Portion of Victoria Specified by this Proclamation to be a Proclaimed Area

Within the Shires of Lilydale, Upper Yarra and Sherbrooke that portion of Victoria commencing from the Town of Monbulk and proceeding in a northerly direction along Monbulk Road to Clegg Road thence in an easterly direction along Clegg Road to the Warburton Highway thence in an easterly direction along the Warburton Highway to Douthie Road thence in a southerly direction to Beenak Road thence in an easterly direction along

Beenak Road to the Macclesfield-Woori Yallock Road thence in a southerly direction along the Macclesfield-Woori Yallock Road to Mulhalls Road thence in a westerly direction along Mulhalls Road to Paton Road thence in a southerly direction along Paton Road to Uren Road thence in a westerly and southerly direction along Uren Road to Holman Road thence in a westerly direction along Holman Road to the Emerald-Monbulk Road thence in a north-westerly direction along the Emerald-Monbulk Road and thence to Monbulk Road in the Town of Monbulk.

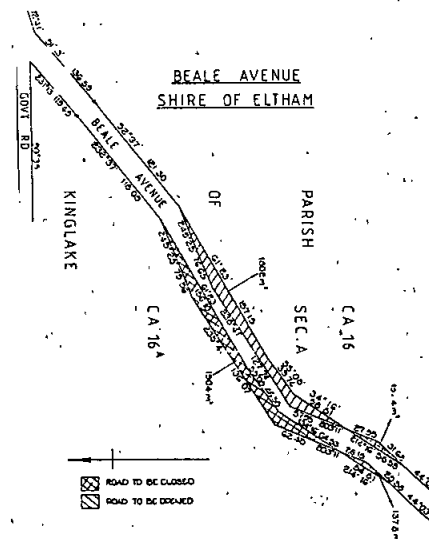

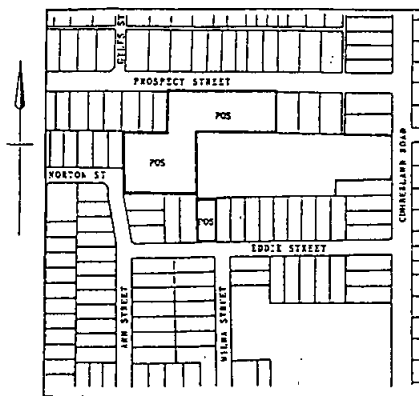

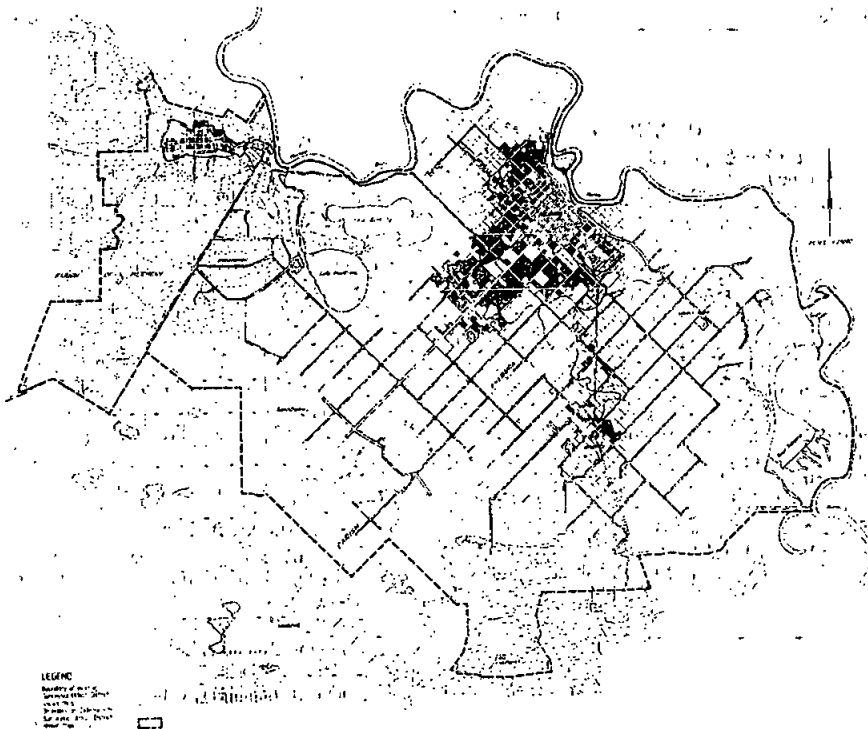

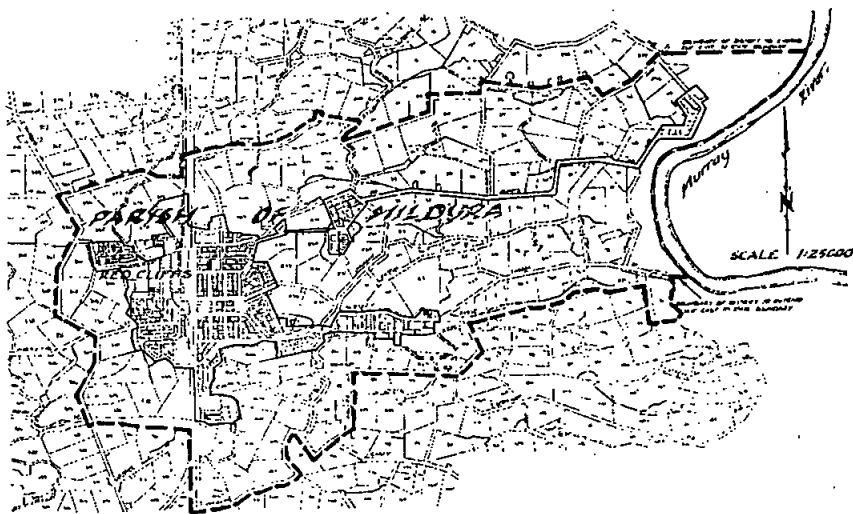
