PM Route. Depart Padua College and travel via Oakbank Road, Nepean Highway, Wilsons Road, Nunns Road, Strachans Road, Nepean Highway, Mornington-Tyabb Road, Jones Road, Frankston-Flinders Road, Watts Road, Hodgins Road, Hunts Road, Coolart Road, Mornington-Tyabb Road, Nepean Highway, Oakbank Road to Padua College.

Note: (i) Passengers will not be picked up/set down along Nepean Highway. (ii) Services to operate under contract to Padua College.

Mamaka Pty Ltd, Dareton. Application to license one commercial passenger vehicle in respect of a 1987 Hino Bus with seating capacity for 28 passengers to operate under charter conditions from within a 20 km pick-up radius of the Mildura Post Office.

Note: The vehicle to be licensed would hold a 4-star rating for charter purposes.

Water Act 1989

NOTICE OF SALE OF LICENCES

Notice is hereby given under section 57 (2) of the *Water Act 1989* that I, John Langford, General Manager of the Rural Water Commission of Victoria (RWCV) as delegate of the Minister have decided to sell licences at auction under section 57 (1) of the Act to take and use water occurring within the area set out below:

The area in Gippsland Region specified in an Order made by the Minister and published in the *Government Gazette* on 20 June 1990. This area is the lands shown within the red border on Plan No. 6155 lodged in the Plan Room of the RWCV, 590 Orrong Road, Armadale. The plan is available for inspection between the hours of 9 a.m. to 4 p.m. Monday to Friday. A copy of this plan is also available for inspection at the RWCV's Regional Office, 2 Pearson Street, Maffra.

I. I declare that persons with the following qualifications may purchase licences in the specified area:

- (a) satisfactory completion of the Pre-Registration Form available from the RWCV office at Maffra, and lodgement of the form at this office by 4 p.m. on Friday 15 February 1991. My decision on whether the form has been satisfactorily completed will be final.

- (b) satisfactory compliance with the following eligibility criteria:

- (i) Location of Holding

Landholders wishing to purchase irrigation water must have access to suitable freehold land located within the red border of Plan No. 6155, either by lease or direct ownership.

- (ii) Supply Route

Landholders must demonstrate that they have a legal access between the

- proposed RWCV source of supply and freehold land on which the entitlement will be used. This access must be suitable for the location of appropriate supply works, including maintenance of required works.
- (iii) **Supply Works**
Landholders must agree to install at their cost, and to RWCV standards, works for the supply of water to lands on which the entitlement will be used. Where entitlement is to be taken through existing supply works, the suitability of these works will be assessed and upgraded as necessary at the landholder's cost.
- (iv) **Maximum Entitlement**
Landholders who purchase water for irrigation purposes would not normally be eligible to purchase volumes greater than that consistent with a maximum unit entitlement rate of 10 megalitres per hectare of suitable land. Bidders wishing to purchase volumes in excess of this upper limit must obtain specific approval of the RWCV prior to auction.
- (v) **Salinity and Drainage**
The land on which the entitlement will be used must be appropriately drained, either by access to RWCV drains or by means of a natural drainage course. Additional allocations would not be made in areas with rising water tables, or existing salinity problems.
- (vi) **Protection of Existing Water Entitlements**
The allocation of additional entitlement will be limited to areas supplied from distribution channels capable of supplying the additional commitment, without adverse effect on the supply of pre-existing entitlement.
My decision on whether landholders have satisfactorily complied with eligibility criteria will be final.
- (c) signing of written agreement to comply with the terms and conditions of the sale.
2. The details of the method by which licences are to be sold is:
- (a) Sale by Auction to the highest qualified bidder.

- (b) Auction to be held on Friday 15 March 1991 at 10.30 a.m. at Memorial Hall, Foster Street, Maffra.
- (c) Terms of the sale at auction are:
- payment of 10 per cent on fall of hammer.
 - balance in 28 days from the date of account.
 - a licence to take and use water will be issued after lodgement of application and payment of all fees and costs including purchase price of water.
3. Conditions to which the licence will be subject are:
- (a) The normal licence conditions as set out on standard Diversion Licence Form GW 13 (September 1990) will apply except for the condition relating to the term of the licence.
- (b) Licences will be issued for an unlimited period. Copies of the proposed licence to be issued can be inspected at the RWCV office at Maffra between the hours of 9 a.m. to 4 p.m.

By-Law 6187

Fixing Fees for Connections to the
Commission's Water Supply System

The Rural Water Commission of Victoria under the provisions of the Water Act makes the following By-law:

1. By-Law No. 6028 of the Rural Water Commission is revoked.
2. This By-law shall apply to and have force in the Millewa and Otway Rural Districts, the Dingee, Macorna, Mitiamo, Murrabit, Pyramid Hill, Otway, Carwarp, Koondrook, Meringur, Nyah, Nyah West, Piangil, Werrimull, Eastern Mallee, Northern Mallee, Southern Mallee, Southern Wimmera and Western Wimmera Urban Districts, the Urban Districts supplied with water from the Coliban System of Waterworks and the Otway Waterworks District.
3. The calculation of fees for connections to the Commission's water supply systems in the beforementioned districts shall be as follows using the component charges set out in Clause 4:
 - (a) For new connections—the fee shall be the sum of the Tapping Charge and Meter Charge for the size connection;

- (b) For a connection replacing an existing connection of like or larger size—the fee shall be the Tapping Charge for the new connection size; and
- (c) For a connection replacing an existing connection of smaller size the fee shall be the sum of the Tapping Charge for the new connection and the difference in Meter Charges for the new and existing meter size.

4. The component charges to be used to calculate the connection fees are as follows:

- (i) Where the work is performed by the Commission—

- (ii) Where it is not possible for the work to be performed by the Commission and permission is granted to a plumber to perform the work, the Tapping Charge shall be \$20 plus the cost of any materials supplied other than the meter and the Meter Charge shall be as in (i) above.

5. The Rural Water Commission may from time to time appoint any person or persons who are authorised to demand, receive, collect and recover the said fees.

The foregoing By-law was made by the Rural Water Commission on 13 December 1990 and the common seal of the Commission was affixed by the authority of the Board.

RURAL WATER COMMISSION OF VICTORIA

By-Law No. 6189

Temporary Transfer of Water Entitlements— Irrigation Districts

The Rural Water Commission under the provision of the Water Act makes the following By-law:

1. By-Law 6078 of the Rural Water Commission is hereby revoked.

2. This By-law comes into operation as on and from 1 December 1990 and applies and has force in the Goulburn-Murray, MacAlister and Campaspe Irrigation District.

3. Transfers will only be permitted within the same source of supply except where water is supplied by a dual source.

4. Water right, licensed diversion volumes or available sales may be transferred.

5. The Rural Water Commission holds right of approval or refusal. Where an application is refused, the relevant advisory committee will be advised of their reason.

6. Transfer will be subject to channel capacity constraints.

7. Transfer will be subject to the buyer having adequate supply works.

8. Approval of the transfer will be subject to maintenance of existing levels of service and any change to this level of service will only be considered after consultation with the relevant advisory committee.

9. Transfers must satisfy specified drainage and salinity criteria, as determined by the Commission, after consultation with advisory committees.

10. If approved, transfers will be effective from the date all the application forms and payment of fees are received at the Regional Office. Any water used as "sales" to that date will be charged for in the normal manner.

11. (a) An \$80.00 fee apply to all and every application for the temporary transfer of water entitlement between any two holdings.

(b) The application fee for Temporary TWE between any two holdings is not refundable.

12. Applications will be dealt with in the order they are received.

13. Applications will be in two parts comprising:

(a) The buyer form which may be signed by the occupier or the registered owner/sharefarmer/lessee of the property to receive the transferred water;

(b) The seller notice of agreement to transfer form which must be signed by the registered owners or written authorisation of the owner giving permission for the occupier/sharefarmer/lessee to negotiate the sale of water.

14. The onus is on irrigators to negotiate and arrange their own transfers.

15. The price per megalitre of water transferred will be a matter for negotiation between the seller and the buyer, and the Commission will not be involved in this aspect.

16. Before water is transferred from a property the consent of a lessee or sharefarmer will be required.

17. (a) Temporary transfers of water rights and/or sales will be permitted from holdings within an irrigation area to other holdings within an irrigation area or supplied by agreement to outside district holdings which are capable of being supplied through existing works; or new works if approved by the Regional Manager, provided that such transfers meet supply, capacity, drainage and salinity criteria.

(b) Temporary transfers of water rights and/or licensed volume and/or available sales will be permitted from/to properties within an irrigation area to/from properties with a diversion licence, provided the water is taken from the same source of supply and provided that such transfers meet supply, capacity, drainage and salinity criteria.

18. Responsibility for payment of irrigation charges and drainage rates raised with respect to water right remains with the seller. The buyer is responsible for payment for sales water used.

19. Landowners shown in the Register of Orchard Plantings in the GMID may participate in TWE, but cannot transfer water off their holdings and retain their guaranteed entitlement of six ml per hectare of plantings.

Industrial Relations Act 1979

CHANGE IN TITLE AND VARIATION OF JURISDICTION OF THE COMMERCIAL CLERKS CONCILIATION AND ARBITRATION BOARD

Pursuant to Decision No. D90/2605 dated 21 December 1990 (Case Nos 89/1026 and 90/1153) the Industrial Relations Commission of Victoria in Full Session ordered:

1. The title of the Commercial Clerks Conciliation and Arbitration Board is changed to the Clerical and Administrative Employees Conciliation and Arbitration Board.

2. The jurisdiction of the Clerical and Administrative Employees Conciliation and Arbitration Board is varied so that, in substitution for the jurisdiction previously conferred upon it, its jurisdiction applies to the whole of Victoria to the process, trade, business or occupation of a person or persons or class of persons (by whatever name called) employed wholly or principally in clerical work and/or office administration; but excluding—

(a) any person employed by a banking company, insurance company or trustee company;

(b) any person subject to the Award of Clerks (Building and Housing Societies) Board, the Clerks (Credit Societies) Board, the Totalizer Employees Board the Off-Course Totalizer Employees Board, the Victorian Fire Services Administrative and Clerical Officers Board, or the Law Clerks Board;

(c) any person who is a proprietor, director or manager of a company, business or undertaking, or a person to whom he or she has delegated the right to engage and terminate the employment of his or her employees.

3. This order shall operate on and from 1 February 1991.

RURAL WATER COMMISSION OF VICTORIA

By-Law No. 6188

Amending By-Law No. 5850 as amended by By-Laws Nos. 5905, 5964, 5955, 6029 and 6050 regulating water supply services in Waterworks, Rural and Urban Districts.

Clause 43 (2) is amended to "The prescribed fee for meter tests requested by such owner or occupier shall be \$35.00".

Purpose of Order

2. The purpose of this Order is to establish the Vocational Education and Training Accreditation Board (VETAB) and to make provision for the terms and conditions of appointment of the members of VETAB, the procedures of VETAB and to impose duties on VETAB under section 75 of the *Vocational Education and Training Act 1990*.

PART 2—THE ACCREDITATION OF COURSES

Establishment

3. In accordance with section 75 of the Act the Vocational Education and Training Accreditation Board (VETAB) is established.

Objectives

4. The objectives of VETAB are—

- (a) to implement the accreditation process in accordance with, and to faithfully exercise and perform all functions, powers and duties imposed or conferred on VETAB by or under the Act;
- (b) to review the accreditation of courses in vocational education and training;
- (c) to report and make recommendations to the State Training Board in relation to accreditation matters such as—
 - (i) accreditation policy;
 - (ii) course development so far as it relates to accreditation;
 - (iii) administrative and organisational arrangements in relation to accreditation;

- (iv) accreditation standards;
- (v) measures to promote course quality and linkages between courses; and
- (vi) measures to promote co-ordination and linkages with courses offered by other sectors of education and by industry;
- (d) to monitor the accreditation procedures of industry training accreditation boards and other persons and bodies exercising accreditation functions under this Act and to advise the State Training Board on the co-ordination of those procedures and the maintenance of accreditation standards;
- (e) to exercise any of the State Training Board's powers under sections 74 or 78 that are delegated to it under section 75 (2) (d) of the Act; and
- (f) to exercise any duty imposed by the Governor in Council under section 75 (6) (b) of the Act.

Duties

5. VETAB must—

- (a) comply with all duties imposed by the Act any relevant instrument of delegation and any other duties imposed by law;
- (b) operate in accordance with economic and social objectives established from time to time by the Government of Victoria;
- (c) operate in accordance with national accreditation guidelines;
- (d) comply with all obligations and duties imposed on VETAB by or under this Order;
- (e) so far as practicable, exercise and perform all rights, powers and duties conferred or imposed on VETAB so as to achieve the objectives of VETAB;
- (f) meet not less than four times in each calendar year and at least once every four months.

Terms and Conditions of Appointment of Members

6. (1) A member will hold office for the period not more than three years which is specified in the instrument of appointment.

(2) A member may resign by writing addressed to the Chairperson of the State Training Board.

(3) A member ceases to hold office if and when that member is absent from three consecutive meetings of VETAB without leave from the Chairperson of the State Training Board.

(4) The Governor in Council may, on the recommendation of the State Training Board, remove a member from office at any time.

(5) A member must in the exercise of his or her functions—

- (a) act honestly; and
- (b) exercise reasonable care and diligence; and
- (c) not make improper use of any information acquired as a member; and
- (d) disclose, in accordance with the Act and with clause 7 of this Order, conflicts of interest or duties.

Disclosure of Interests of VETAB Members

7. (1) VETAB members who are directly or indirectly interested in any business of VETAB or who hold any office or possesses any property which might cause a conflict of duties or interest must declare that interest or potential conflict.

(2) A disclosure of any conflict of interest or duties must be made to the next meeting of VETAB following the member becoming aware of the relevant facts.

(3) All declarations must be recorded in the minutes of VETAB.

(4) A declaration can be in the form of a general notice read at a VETAB meeting and entered in its minutes that the VETAB member holds an office or possesses certain property or has other relevant interests.

(5) The requirements of this clause do not apply to conflicts or potential conflicts in respect of positions, offices of employment held which are a necessary qualification for the appointment of a person to VETAB.

Procedure

8. (1) VETAB must each year select from its members a Deputy Chairperson to hold office during the following calendar year.

(2) The Chairperson will chair meetings of VETAB but if the Chairperson is absent the Deputy Chairperson will chair the meetings. If both the Chairperson and Deputy Chairperson are absent, the members present will choose a member to chair the meeting.

(3) VETAB's quorum is a majority of the members present but a majority of the members present must not be members from the education sector.

(4) VETAB may act despite vacancies in its membership so long as a quorum is present.

(5) Each member has one vote and questions will be decided by a majority of votes but if votes are equal the member chairing the meeting will have a second or casting vote.

(6) VETAB must have accurate minutes kept of its meetings and must arrange for a copy of all minutes to be delivered to the General Manager.

(7) VETAB may form and dissolve committees whose function will be to advise or assist VETAB in relation to the performance or exercise of any of its powers, duties or functions as determined by VETAB from time to time.

(8) VETAB may decide the composition of committees and appointment of committee members provided that—

- (a) VETAB must appoint at least two of its members to every committee; and
- (b) VETAB must appoint the Chairperson of each committee who in each case must be a member of VETAB; and
- (c) VETAB must have the power of appointment and removal of members and the Chairperson of every committee; and
- (d) in deciding the composition of each committee, VETAB will attempt to maintain an appropriate balance of relevant backgrounds and experience; and
- (e) members of committees established by VETAB under clause 8 (7) will hold office for the period (not more than one year) specified in the instrument of appointment; and
- (f) a committee member can resign by writing addressed to the Chairperson of VETAB; and
- (g) a committee may give a committee member leave from attendance at its meetings.

(9) Subject to the Act and this Order, VETAB may regulate its own procedure.

PART 3—ANCILLARY AND TRANSITIONAL

Authority for Order

9. This Order in Council is made under section 75 of the *Vocational Education and Training Act 1990* and all other enabling powers.

Date of Effect

10. This Order in Council takes effect on and from 1 January 1991.

Meaning of Terms

11. In this Order, unless inconsistent with the context or subject-matter:

- “The Act” means the *Vocational Education and Training Act 1990* and includes regulations under that Act;
- “Chairperson” means the Chairperson of the Vocational Education and Training Accreditation Board and includes a person acting in the position of Chairperson;
- “Committee” means a committee of VETAB established in accordance with this Order;
- “Committee Member” means a member of a committee and includes the Chairperson and any acting member nominated in accordance with this Order;
- “Education Sector” means those areas of education which are the responsibility of the Post-Secondary Education Commission, the Victorian Curriculum and Assessment Board and the State Training Board;
- “General Manager” means the person for the time being holding, acting in or performing the duties of the office of General Manager of the State Training Board within the meaning of the Act;
- “Member” means a member of VETAB and includes the Chairperson;
- “State Training Board” means the State Training Board established by the Act;
- “Vocational Education and Training Accreditation Board” means the Board established by clause 3 of this Order;
- “VETAB” means the Vocational Education and Training Accreditation Board established by clause 3 of this Order.

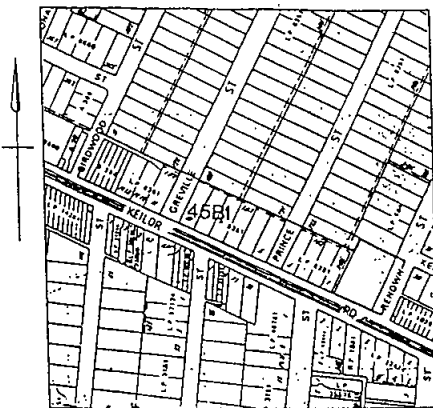
