PROCLAMATION

By His Excellency the Honourable Richard Elgin McGarvie, Governor of the State of Victoria in the Commonwealth of Australia.

Her Majesty has been graciously pleased by Commission under Her Royal Sign Manual and the Public Seal of the State of Victoria dated at Her Majesty's Court at St. James's on 10 April 1992, to appoint me, Richard Elgin McGarvie, to be Governor of the State of Victoria in the Commonwealth of Australia:

I hereby proclaim and declare that I have today taken the prescribed oaths before the Honourable John Harber Phillips, Chief Justice of the Supreme Court of Victoria, and before the Executive Council of the State, at Parliament House, Spring Street, Melbourne, and I have assumed the Office of Governor of the State of Victoria under and by virtue of Her Majesty's Commission.

Given under my hand and the Seal of the State of Victoria, 23 April 1992 in the forty-first year of the reign of Her Majesty Queen Elizabeth II, Queen of Australia.

Elizabeth the Second, by the Grace of God Queen of Australia and Her other Realms and Territories, Head of the Commonwealth:
To the Honourable Richard Elgin McGarvie, Greeting:

We hereby appoint you, Richard Elgin McGarvie, to be, during Our Pleasure, Our Governor of Our State of Victoria, in the Commonwealth of Australia.

And we hereby authorise, empower, and command you to perform the powers and functions of the Office of Governor in accordance with the *Constitution Act 1975* of Victoria, the *Constitution Amendment Act 1958* of Victoria, the *Australia Acts 1986* of the Commonwealth of Australia, and of the United Kingdom, and Our Letters Patent dated at

Westminster 14 February 1986, and any other Letters Patent in force from time to time under clause X of Our Letters Patent of 14 February 1986.

And as soon as you have taken the prescribed Oaths and have entered upon the duties of your Office of Governor, this Commission shall supersede our Commission dated 9 January 1986, appointing the Reverend Doctor John Davis McCaughey A.C. to be Governor of Our State of Victoria.

And we hereby command all our subjects in Our State of Victoria and all other persons who may lawfully be required to do so to give due respect and obedience to the Governor accordingly.
