Notice of Regulatory Impact Statement

It is proposed that new Regulations be made to replace the State Electricity Commission Electrical Contractors' Registration Regulations 1974.

The objectives of the Regulations are to:

- (a) ensure worker safety;
- (b) ensure installation safety;
- (c) provide a means of control of and communication with electrical contractors;
- (d) ensure minimum competence of electrical contractors;
- (e) assist with national uniformity of electrical contracting requirements.

A Regulatory Impact Statement has been prepared and this concludes that the proposed Regulations are the most viable means of achieving the objectives. The potential benefits to the community of adopting the proposed Regulations outweigh any disadvantages.

**EVIDENCE (CROWN WITNESSES
ALLOWANCES) REGULATIONS 1992**

Notice is given of a proposed regulation under section 152 of the *Evidence Act 1958*, in accordance with the provisions of the *Subordinate Legislation Act 1962*.

The proposed regulation will remake, in similar terms, the Evidence (Crown Witnesses Allowances) Regulations 1982 which will cease to operate on 30 June 1992 under the provisions of the *Subordinate Legislation Act 1962*.

The objective of the proposed regulation is to provide allowances to Crown witnesses appearing in criminal trials and coroners' inquests.

A Regulatory Impact Statement has been prepared as required by the *Subordinate Legislation Act 1962*, which concludes that the proposed regulation provides the most equitable, efficient and cost effective option to achieve this objective.
