LOTTERIES GAMING AND BETTING (RAFFLES AND BINGO PERMITS) REGULATIONS 1992

On 1 August 1992 the Lotteries Gaming and Betting (Raffles and Bingo Permits) Regulations 1982 will sunset.

As required by the Subordinate Legislation Act 1962, notice is given of the intention to

remake the above regulations under the Lotteries Gaming and Betting Act 1966.

The objectives of these Regulations are to provide an administrative framework for the approval and conduct of minor gaming activities and to prescribe fees pursuant to the Act.

A Regulatory Impact Statement has been prepared and concludes that the Regulations fulfil the requirements of the *Lotteries Gaming and Betting Act* 1966 and provide assurances to the community that minor gaming activities will be conducted fairly and honestly by approved organisations and at a minimum cost to the participants.

Comments and submissions are invited from the public, and will be received up to 21 days from the date of publication of this notice.
