*Public Sector Management Act 1992*  
**ORDER PURSUANT TO SECTION 104**

The Governor in Council, under section 104 of the *Public Sector Management Act 1992*, and all other enabling powers, terminates, on 20 November 1992, those parts of the agreements registered under the *Industrial Relations Act 1979* listed in the Schedule.

**SCHEDULE**

1. Agreement between the Ministry of Education and Training and the Victorian Secondary Teachers Association, on conditions and staffing in Secondary Colleges, and the Secondary Sector of P-12 Colleges, Central Schools and Community Schools for 1991, 1992 and 1993.

3. Agreement between the Department of School Education and the Federated Teachers' Union of Victoria on conditions and staffing for 1990, 1991, 1992 and 1993 in Primary Schools, Special Schools and Special Developmental Schools.

Clauses 12.5 to 12.8, 12.10, 13, 14, 15 (except 15.9), 16.1.1 to 16.1.12 (except 16.1.8), 17.1, 17.3, 20.4, 20.5 and 22.
