DIAMOND VALLEY PLANNING SCHEME

Notice of Approval of Amendment

Amendment RL145

The Minister for Planning and Housing has approved Amendment RL145 to the Diamond Valley Planning Scheme.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment rezones land currently within the grounds of the Larundel Hospital partly to Strathallan Residential Zone, partly to a Public Open Space reservation and partly to a Public Open Space—Environmental reservation.

The Strathallan Residential Zone will allow development of the land for residential purposes consistent with the Government's urban consolidation objectives. The Public Open Space—Environmental reservation provides for a wildlife habitat link between the Gresswell Forest and wildlife habitats within the La Trobe University. The Public Open Space reservation generally includes the Strathallan Golf Course and will act as a substantial buffer between the habitat link and residential development.

A copy of the amendment can be inspected, free of charge, during office hours, at the offices of the Shire of Diamond Valley, Civic Drive, Greensborough and at the Department of Planning and Housing, 477 Collins Street, Melbourne.
