WATER ACT 1989

I, Steve Crabb, Minister for Water Resources, make the following Order:

AMENDMENT TO THE CONSTITUTION OF THE COLIBAN REGION WATER AUTHORITY ORDER 1992

- 1. This Order is called the Amendment to the Constitution of the Coliban Region Water
- Authority Order 1992.
 2. This Order takes effect on and from 30 March 1992.
- 3. The Constitution of the Coliban Region Water Authority Order 1992 published in the Government Gazette on 25 March 1992 is amended as follows:
 - (a) In the definition of "Former Authorities" in Clause 4 of the said Order omit—
 - "the Heathcote Water Board"; and
 - (b) In Clause 6 (a) of the said Order omit—
 "(vii) Heathcote Urban;
 - (viii) Heathcote Waterworks; and
 - (iv) Tooborac Urban;" and

"Heathcote Sewerage".

WATER ACT 1989

I, Steve Crabb, Minister for Water Resources, make the following Order:

APPOINTMENT OF THE COLIBAN REGION WATER AUTHORITY ORDER 1992

1. This Order is called the Appointment of the Coliban Region Water Authority Order 1992.

- 2. This Order is made under the powers conferred by Division 2 of Part 6 of the *Water Act* 1989 and all other available powers.
- 3. This Order takes effect on 13 April 1992.
- 4. In this Order-
 - "Act" means the Water Act 1989.
 - "Former Authority" means the Heathcote Water Board.
- 5. On and from the date on which this Order takes effect the Coliban Region Water Authority is appointed to take over—
 - (a) the whole of the property, rights, liabilities, obligations, powers and functions under the Act of the Former Authority including the management and control of the existing water districts named below—
 - (i) Heathcote Urban;
 - (ii) Heathcote Waterworks; and
 - (iii) Tooborac Urban-

and the management and control of the existing sewerage district named below-

Heathcote Sewerage; and

- (b) all the staff of the Former Authority.
- 6. The Former Authority is abolished.
- 7. (a) This is an Order referred to in section 98 (2) (b) of the Act; and
- (b) Under section 100 (1) (a) of the Act I have advised the affected Authority in writing of the reasons for my decision; and
- (c) Under section 100 (1) (b) of the Act I have made sure that a copy of the reasons has been laid before both Houses of Parliament.
