Amendment L8

The Minister for Planning and Housing has approved Amendment L8 to the Strathfieldsaye Planning Scheme.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment is an interim control applying to subdivision and houses in the "Rural A" and "Rural Residential A" zones of Chapter 3 (rural areas) of the Local Section. The amendment will expire on 31 December 1992. The main features of the amendment are:

- (1) Introduces a minimum subdivision control of 40 ha over most of the "Rural A" zone.

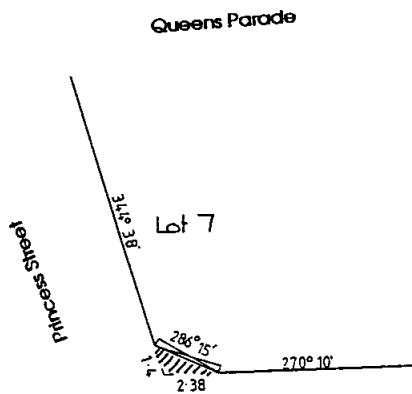

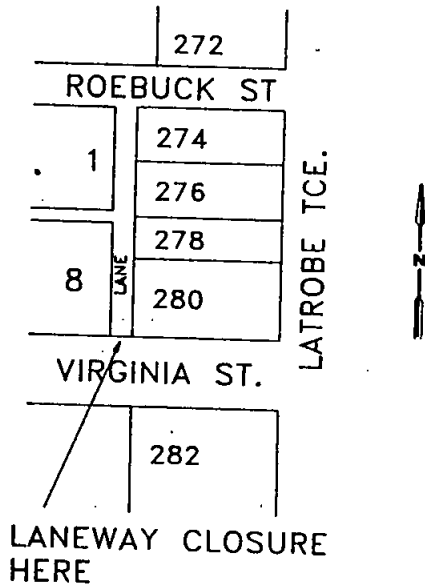

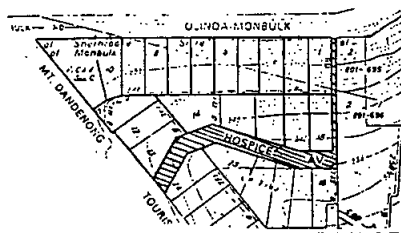
