



may adversely affect the enjoyment of life within the municipal district or the health, safety and welfare of persons within the municipal district;

- (k) to provide and control for the management of traffic, use of roads by persons, vehicles and animals and to regulate the parking of vehicles for the safety and fair use by people in the municipal district;
- (I) in a way which is consistent with, and in furtherance of, the objectives specified in paragraphs (a) and (k) of this clause to prohibit, regulate and control activities and circumstances associated with such activities, events, practices or behaviour in places so that no detriment is caused to the amenity of the neighbourhood, nor nuisance to a person, nor detrimental effect to a person's property;
- (m) to provide generally for the peace, order and good government of the municipal district;
- (n) to provide for the administration of the Council's powers and functions;

Part 1-Provisions

Division 1: Title, Objectives etc.

This Division covers the statutory requirements for the making of the Local Law and includes definitions of words used in the Local Law.

Division 2: Administration

This Division covers the administrative procedures for the Local Law including the powers of an Authorised Officer and the provision for a Notice to Comply.

Division 3: Fees, Charges and Costs

This Division provides for the setting for fees and charges.

Part 2-Protection of Council Land

This Part contains clauses which regulate certain actions in order to protect council land including:

1. Preventing damage to Council drains, water courses, bridges, culverts, fences, etc.;

- 2. Providing for the construction of vehicle crossings;
- 3. Providing for the construction of temporary vehicle crossings;
- 4. Preventing damage or interference with Council land;
 - 5. Regulating fires on Council land;
- Preventing trees of plants causing damage to Council land;
- 7. Preventing the dumping of items on Council land.

Part 3—Use of Roads, Public Places and Council land

This Part provides for controls over the use of roads, public places and Council land including: Division 1: Municipal Buildings

- Providing for hours and condition under which municipal buildings may be used;
- Providing for the availability and hire of municipal buildings;
- 3. Providing for the conditions of entry to a municipal building;
- 4. Prohibiting persons from certain behaviour in a municipal building;
- 5. Prohibiting certain articles from being taken into a municipal building.

Division 2: Rubbish Depot

- Providing for the conditions of entry to the rubbish depot;
- 2. Prohibiting persons from certain behaviour at the rubbish depot.

Division 3: Public Reserves and Recreation Lands

- 1. Providing for conditions of access to reserves:
 - 2. Regulating the use of reserves;
- 3. Prohibiting persons from certain behaviour in reserves.

Division 4: Roads, Public Places and Council Land—Obstructions and Behaviour

- 1. Regulating the leaving of shopping trolleys on any road, Council land or public place;
- 2. Prohibiting dog excrement on any road, Council land or public place;
- 3. Providing controls for the use of skateboards, rollerskates, rollerblades and other "toy vehicles";
- 4. Prohibiting certain obstructions from being placed on any road, Council land or public place;

- 5. Regulating the servicing or repairing of a vehicle on a road, Council land or public place;
- 6. Regulating the identification of premises;
- Regulating the riding, driving and grazing of animals on a road or Council land or public place;

- 9. Regulating the use of certain types of vehicles on a road, Council land or public place;

Division 5: Consumption of Liquor

Regulating the possession or consumption of liquor in certain municipal and public places.

Part 4—Street Selling, Collections, Distributions and Entertainment

This Part regulates activities relating to street selling, collections, distributions and entertainment including such activities as:

- 2. Door to door collections;
- 3. Distribution of advertising material;

 - 5. Busking and street entertainment:
 - 6. Circuses, carnivals and festivals.

Part 5—Protection of the Amenity of the Municipal District

This Part regulates certain activities in order to protect, conserve and control the environment and amenity of the municipal district and to suppress nuisances including:

Division 1: Unsightly or Dangerous Land

- Prohibiting the keeping of a property in such a way that it might constitute fire hazard;
- 2. Preventing the keeping of land in such a way that it is unsightly or dangerous;
- 3. Regulating the activities of heavy vehicles in built-up areas;
- 4. Regulating the keeping of trees or shrubs in such a way that they obstruct vehicles or pedestrians;



- (vi) revoke By-laws numbered 60 and 75;
- (vii) provide generally for the peace, order and good government of the municipal district.

The general purport of the Local Law includes a specification of the law which will regulate the use of the common seal and prohibit unauthorised use of the common seal or any device resembling the common seal, election of the Mayor and Chairpersons of various committees. The Local Law regulates proceedings at Council meetings, special committee meetings, advisory committee meetings and other meetings.
