Notice of Regulatory Impact Statement

Pursuant to the *Architects Act 1991* it is proposed to make the Architects Regulations 1993.

The objectives of the regulations would be:

1. To maintain the quality of architects' services and facilitate the redress of consumers' grievances by defining for architects and their clients the standards of professional conduct and practice required of the architect when engaged for architectural services.
2. To establish arrangements and definitions which will enable the Architects Registration Board of Victoria to implement the purposes of the *Architects Act 1991* and carry out the functions required of it by the Act.

A Regulatory Impact Statement has been prepared which concludes that the proposed regulations are the most effective means of achieving these objectives.
