Road Safety Act 1986 MOTORCYCLE RELIABILITY TRIAL

Under section 68 (3) of the Road Safety Act 1986, I declare that sub-sections (1) and (2) of section 68 of the Act, the Road Safety (Traffic) Regulations 1988 and parts 9 and 10 of the Road Safety (Vehicles) Regulations 1988 shall not apply with respect to the event known as the Round 2 Victorian Enduro Series to be conducted by the Dandenong Motorcycle Club on sections of road within the Erica Forest District on Sunday, 18 April 1993, between the hours of 8.00 a.m. and 4.00 p.m.
