Wildlife Act 1975

REVOCATION OF PART OF NOTICE OF CLOSURE OF AREA TO HUNTING

I give notice under section 86 of the *Wildlife Act 1975*, that the "Notice of closure of areas to hunting" published in *Special Government Gazette* No. S26 on 21 April 1993, is revoked to the extent that it prohibits the hunting, taking or destroying of wildlife in the areas described in Schedules 1 and 2 of that Notice and described below.

SCHEDULE 1

Hirds Swamp, Shire of Kerang—situated adjacent to the Kerang–Leitchville Road, 19 km west of Leitchville.

SCHEDULE 2

McDonalds Swamp, Shire of Kerang—situated 1 km south of the Kerang–Koondrook Road, 10 km south-west of Koondrook and adjacent to Craigs Road on the north side.

Note: The closure of Second Marsh (described in Schedule 3 of the Notice published on 21 April 1993) remains in force for the period ending on 31 May 1993.
