## *Land Act 1958* APPROVAL BY THE GOVERNOR IN COUNCIL OF CROWN LAND FOR SALE BY PRIVATE TREATY

The Governor in Council under section 99A (1) (a) of the *Land Act 1958* makes this Order approving for sale by private treaty the following Crown land described in the Order:

Land surrendered to the Crown under section 22A of the *Land Act 1958* by the Public Transport Corporation, being land—

- (a) which is described in the Schedule to this Order; and
- (b) which immediately before its surrender—
  - (i) was subject to a lease or tenancy to a lease or tenancy agreement entered into by the Public Transport Corporation; and
  - (ii) was surplus land under section 47 of the *Transport Act 1983*; and
- (c) which is to be sold to the party specified in the lease as the lessee or in the tenancy agreement as the tenant or that lessee's or tenant's nominee.

The Minister for Planning has approved Amendment L134 to the Local Section of the Melbourne Planning Scheme.

Amendment L134 amends the Local Section (Part 1) of the Melbourne Planning Scheme to facilitate the use of the John Elliott Stand, function rooms and private viewing boxes at the Carlton Recreation Ground in Princes Park, Carlton, in association with an international soccer match to be held at the Ground on 17 June 1993.
