*Subordinate Legislation Act 1962*  
**CONSTRUCTION INDUSTRY LONG  
SERVICE LEAVE REGULATIONS 1993**

Under the provisions of the *Subordinate Legislation Act 1962*, notice is given of the above proposed Regulations under the *Construction Industry Long Service Leave Act 1983*.

The Regulations will replace the Construction Industry Long Service Leave (General) Regulations 1983 and the Construction Industry Long Service Leave (Construction Industry Long Service Leave Board Fees and Allowances) Regulations 1983. Both of these Regulations will be revoked on 31 July 1993 by the sunset provisions of the *Subordinate Legislation Act 1962*.

The objectives of the Regulations are to prescribe certain matters for the purposes of the *Construction Industry Long Service Leave Act 1983*. For example, the percentage amount of ordinary pay for long service leave charges, surcharges, returns that employers must make and fees and expenses payable to the Chairperson and members of the Construction Industry Long Service Leave Board.

A Regulatory Impact Statement has been prepared as required by the *Subordinate Legislation Act 1962* and concludes that the Regulations are the most efficient and equitable means of achieving the objectives.
